No. 599 (E), dated 19-6-2017 in Gazette of India, Extraordinary, No. 497, Part-II, Section 3 – Sub-section (i), dated 19th June, 2017 to amend the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996 and the same is hereby republished for general information of the public.

NOTIFICATION

New Delhi, the 19th June 2017.

G.S.R. 599 (E).— In exercise of the powers conferred by section 32 of the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994 (57 of 1994), the Central Government hereby makes the following further amendments to the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996, namely:-

1. (1) These rules may be called the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Amendment Rules, 2017.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996, in rule 5, in sub-rule (1), after the proviso, the following proviso shall be inserted, namely:-

“Provided further that no Government Institution which provides health and medical services shall be required to pay fee for registration and renewal of registration”.
