### IN THE COURT OF THE DISTRICT MAGISTRATE AT PUDUCHERRY

PROCLAMATION UNDER SECTION 8 (2) (a) OF THE PUDUCHERRY  
PREVENTION OF ANTI-SOCIAL ACTIVITIES ACT, 2008 AND UNDER  
SECTION 82 OF CR.P.C REQUIRING THE APPEARANCE OF ABSCONDING  
PERSON UNDER PUDUCHERRY PREVENTION OF  
ANTI-SOCIAL ACTIVITIES ACT, 2008

### NOTIFICATION

Whereas, a detention Order was issued against Thiru Vinoth @ Vinothkumar @ Salim, S/o. Segar, resident of No. 19, Mariamman Koil street, Aranganoor, Bahoor Commune, Puducherry vide order No. 10/DM/RO/D2/PPASAA/2017, dated 16-7-2017 under the provisions of Puducherry Prevention of Anti-Social Activities Act, 2008 (Act No. 10 of 2010) and the said detention order had also been approved by the Government of Puducherry within the stipulated period of 12 days as prescribed in the said Act vide G.O. Ms. No. 40, dated 25-7-2017 of Home Department, Puducherry;

And Whereas, the Station House Officer, Bahour Police Station has reported that from the 17-7-2017 *i.e.*, next day from the date of issue of detention order, the abovesaid person is found absconding and evading the execution of the said detention order and his whereabouts are not known. All necessary efforts were taken by Station House Officer, Bahour Police Station, Puducherry to secure and detain Thiru Vinoth @ Vinothkumar @ Salim, S/o. Segar under the abovesaid detention order, but, still he is found absconding, concealing himself and evading his arrest and efforts are being continued to execute the detention order made against him.

And whereas, it has been shown to my satisfaction that Thiru Vinoth @ Vinothkumar @ Salim, S/o. Segar has absconded or concealing himself and evading his arrest;

Now, therefore, proclamation is hereby made that the said absconding person Thiru Vinoth @ Vinothkumar @ Salim, S/o. Segar, resident of No. 19, Mariamman Koil Street, Aranganoor, Bahour Commune, Puducherry is hereby ordered to appear before the undersigned at I Floor, Vazhudavur Road, Petaiyanchathiram, Puducherry-605 009, to submit his explanation for the allegations of the Station House Officer, Bahour Police Station, Puducherry, on the 21st day of September 2017, at 11.00 a.m.
