**ORDER**

In exercise of the powers conferred under section 127 of the Puducherry Co-operative Societies Act, 1972, Thiru R. Rangababu, Co-operative Officer was appointed *vide* Proceedings No. 7/1/1/RCS/Liq./16/2015/139, dated 15-6-2015 of the Registrar of Co-operative Societies, Puducherry, as “Liquidator” for Puducherry region in respect of Co-operative Societies liquidated under section 126 of the said Act.

2. Whereas, Thiru Lanka Veerasamy, Co-operative Officer, is transferred and posted as “Liquidator”, *vice* the said Thiru R. Rangababu, Co-operative Officer *vide* Office Order No. 510/RCS/Estt./E6/2017/55, dated 11-7-2015 of the Registrar of Co-operative Societies, Puducherry. The said Thiru Lanka Veerasamy, Co-operative Officer reported for duty *vide* Joining report, dated 13-7-2015 of Thiru Lanka Veerasamy, Co-operative Officer, to assume charges as Liquidator.

3. In view of the above and in exercise of the powers conferred under section 127 of the Puducherry Co-operative Societies Act, 1972, read with Rule 66 of the Puducherry Co-operative Societies Rules, 1973, the undersigned hereby appoint Thiru Lanka Veerasamy, Co-operative Officer as "Liquidator" for Puducherry region and empower him to function as per the provisions of the said Act and Rules, for the purpose of cancellation of registration of one hundred and thirty-three Co-operative Societies listed in the Annexure. which were liquidated under section 126 of the said Act.

NOTIFICATION

Whereas, the Lieutenant-Governor, Puducherry, has by notification *vide* G.O. Ms. No. 9/95/Lab., dated 7-4-1995 under sub-section (1) of section 52 of the Puducherry Shops and Establishments Act, 1964 authorized the Secretary to Government, Labour Department, Puducherry to exercise the powers of the Government under section 6 of the said Act relating to exemption;

And whereas, M/s. Thillai's Food Park, 161, Church Street, Karaikal has applied for grant of exemption from section 14(1) of the said Act to run the shop on weekly holidays since, the shop is dealing with highly perishable items in addition to the other products catering to the daily needs of the public;

Now, therefore, considering the reasons stated, the Secretary to Government, Labour Department in exercise of the powers conferred by section 6 of the said Act, hereby exempts M/s. Thillai's Food Park, 161, Church Street, Karaikal from the provisions of section 14(1) of the Puducherry Shops and Establishments Act, 1964 for a period of one year from the date of issue of this notification subject to the following conditions:-

- (1) Every employee, employed in the shop should be allowed a weekly holiday with wages without fail on a staggered weekly off basis.
- (2) No employee should be allowed to work continuously for 7 days in a week.
- (3) The employer, on any account, should not seek the service of an employee on his weekly off day.
- (4) The employer should display all the notices and required documents and should show to the Inspectors during inspection.
- (5) In the event of any complaints regarding the weekly holiday, the above exemption will be cancelled.

ORDER

Whereas, charges were framed against Thiru G. Vadivelu, Bhandar Manager Gr. II under rule 14 of CCA (CCS) rules, 1965 and communicated *vide* Charge Memorandum of even No. dated 11-11-2011. The Articles of charges were that (i) unauthorized from duty from 3-12-2010 onwards till date and (ii) insubordination to the orders of superiors.

Whereas, the said Thiru G. Vadivelu, Bhandar Manager Gr. II, the Charged Official has neither received the charged memorandum nor submitted the statement of defence for the charges levelled against him.

Whereas, the Under Secretary, Departmental Inquiry, Puducherry and Superintendent (PKVIB) had to be appointed as Inquiring Authority and Presenting Officer respectively *vide* Orders of even No. dated 20-2-2012 and 31-8-2016 appointing Presenting Officer and Inquiry Authority respectively.

Whereas, the Inquiring Authority after observing required formalities had submitted the Inquiry Report *vide* Report No. 06/2016-US(DI)/CS, dated 16-3-2017 of the Inquiring Authority. According to the report, the said two charges levelled against the charged official stands proved.

Whereas, the said report of the Inquiry Authority was forwarded to the last known address of the Charged Official by RPAD to make any representation or to heard in person *vide* Memorandum of even No. 20-4-2017.

And whereas, the said postal communication has been returned as "Not Claimed" *vide* Returning of Postal Communication, dated 2-5-2017.

Now, therefore, the undersigned in the capacity of Disciplinary Authority in the instant case, after gone through the relevant records on applying his mind taking into account the prolonged absence from duty for more than six years and ample opportunity given to the Charged Official imposes on Thiru G. Vadivelu, Bhandar Manager Grade-II, the Charged Official the penalty of "Dismissal" from service with immediate effect.

The period of absence from duty from 3-12-2010 to 23-6-2017 is treated as '*Dies non*'.

The receipt of the order shall be acknowledged.

Previously, the order, dated 27-6-2017 was attempted to serve on the Charged Official by RPAD. Whereas, the said postal communication has been returned on 11-7-2017 as "Door closed" despite intimated on three occasions and hence this notice.

NOTIFICATION

The Ministry of Health and Family Welfare, Government of India has notified National Health Accounts (NHA) guidelines for India, 2016 with a view to implement State Health Accounts which is a useful tool in describing a country's health system from an expenditure perspective and to provide inputs on how much is spent on health and type of services and beneficiaries.

2. The main objective is to form a Steering Committee to ensure high-level supervision and commitment from the State Government and provide guidance on policy direction of State Health Accounts (SHA).

3. The Terms of Reference of the Committee are as under:

(i) The Steering Committee would guide, advice and provide strategic direction in the preparation of State Health Accounts.

(ii) To oversee and coordinate with the State Departments, Research Institutions and other professional bodies, for aiding in collection, collation and validation of State Health Accounts estimates.

(iii) Any other matter related to the Estimation of the National Health Accounts.

(iv) Steering Committee is a permanent body with a flexibility to make changes to its members once in two years. The Chairman, if deemed necessary, may add members to the Committee.

(v) The Steering Committee is expected to meet at least twice a year to take a stock of State Health Accounts related activities.
