**further to amend the Puducherry Court-Fees and
Suits Valuation Act, 1972.**

BE it enacted by the Legislative Assembly of
Puducherry in the Sixty-eighth Year of the Republic of
India as follows:—

Short title and
commencement.

1. (1) This Act may be called the Puducherry
Court-Fees and Suits Valuation (Amendment) Act, 2017.

(2) It shall come into force on such date as the
Government may, by notification in the Official Gazette,
appoint.

Amendment
of section 63.

2. In section 63 of the Puducherry Court-Fees and
Suits Valuation Act, 1972, (hereinafter referred to as the
Principal Act) for the existing section, the following shall
be substituted, namely:-

No. 6
of
1973.

"63. Collection of fees by stamps or e-stamps.—

All fees chargeable under this Act shall be
collected by stamps or e-stamps."

Amendment
of section 64.

3. In section 64 of the Principal Act, for the existing
section, the following shall be substituted, namely:-

"64. Stamps to be impressed or adhesive
or e-stamps.— The stamps used to denote any fee
chargeable under this Act shall be impressed or
adhesive or partly impressed and partly adhesive
or e-stamps, as the Government may, by notification
in the Official Gazette, from time to time direct."
