NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F.5/4/65-GP., dated the 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in partial modification of the Government of Puducherry, Commercial Taxes Department, notification issued in G. O. Ms. No. 5/CT/A1/2016, dated 15th January, 2016 and published as a Supplement to the Gazette No. 8 of the 23rd February, 2016, the Lieutenant-Governor, Puducherry, hereby makes the following rules further to amend the Government of Puducherry, Commercial Taxes Department, Group 'C' Non-Gazetted post of Assistant Commercial Tax Officer Recruitment Rules, 2014 namely:—

1. *Short title and commencement.*— (i) These rules may be called the Government of Puducherry, Commercial Taxes Department, Group 'C' Non-Gazetted post of Assistant Commercial Tax Officer Recruitment (Amendment) Rules, 2017.

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of Rule-2.*— For rule 2 of the Government of Puducherry, Commercial Taxes Department, Group 'C' Non-Gazetted post of Assistant Commercial Tax Officer Recruitment Rules, 2014 (hereinafter referred to as the said rules), the following shall be substituted, namely:—

"2. *Number of post, its classification and Level in the Pay Matrix.*— The Number of the said post, its classification and Level in the Pay Matrix attached thereto, shall be as specified in Columns (2) to (4) of the Schedule annexed hereto".

3. *Amendment of the Schedule.*— In the Schedule to the said rules—

(a) In column 4, for the column heading and entries relating thereto, the following column heading, and entries shall be substituted, namely:—

"4. Level in the Pay Matrix : Level - 5 (₹ 29,200)"

(b) In column 10, for item (ii) of the Note, the following shall be substituted, namely:—

"(ii) Test in Puducherry General Sales Tax Act, 1967 and rules framed thereunder, Puducherry Value Added Taxes Act, 2007 and rules framed thereunder, Central Sales Tax Act, 1956 and rules framed thereunder, Central Goods and Services Act and Rules, 2017, State Goods and Services Tax Act and Rules, 2017, Integrated Goods and Services Tax Act and Rules, 2017 and notifications issued thereunder".

(c) In column 11, for item (ii), the following shall be substituted, namely:—

"(ii) Test in Puducherry General Sales Tax Act, 1967 and rules framed thereunder, Puducherry Value Added Taxes Act, 2007 and rules framed thereunder, Central Sales Tax Act, 1956 and rules framed thereunder, Central Goods and Services Act and Rules, 2017, State Goods and Services Tax Act and Rules, 2017, Integrated Goods and Services Tax Act and Rules, 2017 and notifications issued thereunder".
