ORDER

In pursuance of G.O. Ms. No. 127/LAS/97, dated 10-11-1997, read with G.O. Ms. No. 103/LAS/2007, dated, 17-3-2008, the Government have issued orders and guidelines for implementation of the Scheme and for monitoring the Members of Legislative Assembly's Local Area Development Funds. Accordingly, all the elected and the nominated Members of Legislative Assembly have become eligible to be allotted ₹ 1.00 crore (Rupees one crore) annually as the fund for undertaking works which could be taken up under the Scheme and in accordance with the procedures for implementation of the Scheme.

2. While so, the Hon'ble Chief Minister has given an assurance on the Floor of the Legislative Assembly for enhancement of the allocation of funds under the Members of Legislative Assembly-Local Area Development Scheme to ₹ 2.00 crores (Rupees two crores). Accordingly, the allotment of funds to each elected and the nominated Members of Legislative Assembly under the Members of Legislative Assembly-Local Area Development Scheme is hereby enhanced to ₹ 2.00 crores (Rupees two crores), with effect from the financial year 2016-2017.

3. The Local Administration Department should *adhere* to the Guidelines issued *vide* G.O. Ms. No. 127/LAS/97, dated 10-11-1997 read with G.O. Ms. No. 103/LAS/2007, dated 17-3-2008 of Local Administration (Secretariat) while releasing the funds to the Local Bodies for implementing the Member of Legislative Assembly-Local Area Development Scheme.

4. The Local Administration Department is directed to incorporate the provision of fund in the Draft Annual Plan 2017-18. :
