NOTIFICATION

In pursuance of paragraph 8 of the Scheme set forth in schedule-B to the notification issued under G.O. Ms. No. 200, dated the 6th August, 1980 of the Local Administration Department, Government of Puducherry, the General Committee of the Chief Minister's Relief Fund, hereby makes the following bye-laws further to amend the Chief Minister's Relief Fund

(Grant of Financial Assistance to Media Person) Bye-laws, 1999 issued under Order No. 8-106/OCM/A2/98-99, dated 3rd February, 1999 of the Office of the Council of Ministers, Government of Puducherry and published in Part-II of the Extraordinary Gazette No. 8, dated 23rd February, 1999, namely:—

1. *Short title.*— These bye-laws may be called the Chief Minister's Relief Fund (Grant of Financial Assistance to the Media Person) [Amendment] Bye-laws, 2017.

2. *Amendment of para 2.*— In para 2 of the Chief Minister's Relief Fund (Grant of Financial Assistance to the Media Person) Bye-laws, 1999 [hereinafter referred to as the said Bye-laws], namely:—

In clause (a), for the word and figures "Rs. 25,000", the symbol and figures "₹ 50,000" shall be substituted.

3. *Amendment of para 5.*— In para 5 of the said bye-laws, for the word and figures "Rs. 25,000", the symbol and figures "₹ 50,000" shall be substituted.

4. *Amendment of para 6.*— In para 6 of the said bye-laws for the words, "The application for grant of financial assistance under these bye-laws shall be submitted to the Member-Secretary-cum-Treasurer in Form-I accompanied by the following certificates," the following shall be substituted:—

"Media Person who have completed 10 years shall submit an application in Form-I and the Media Person who completed 20 years and have received financial assistance from the Chief Minister's Relief Fund shall submit an application in Form-I A for the grant of financial assistance under these bye-laws to the Member-Secretary-cum-Treasurer accompanied by the following certificates."

5. *Amendment of Form.*— In the said bye-laws, after the existing Form-I, a new Form-I A shall be inserted, namely:—
