IN THE COURT OF THE DISTRICT MAGISTRATE AT PUDUCHERRY

ORDER UNDER SECTION 144 of Cr. P.C.

Whereas, the Assembly session is proposed to commence for two days on 24-1-2017 and 25-1-2017;

And whereas, political parties, various organizations, agriculturists, labourers, students may resort to demonstrations, *etc.*, thereby threatening the security. Such scenario encourages the agitators conduct snap demonstrations with their available strength while Assembly session is in progress;

And whereas, there are sufficient grounds for passing orders under section 144 of the Code of Criminal Procedure, 1973, to prohibit any means of assembly for the purpose of conducting demonstration, dharna, hunger strike, picketing, *etc.*, by various political parties, organizations and associations of Government employees, labour unions, agriculturists, fishermen, students, *etc.*, and also to carry any type of placards, banners, flags, sticks, *etc.*, within the jurisdiction of Grand Bazaar Police Station and Orleanpet Police Station;

Now, therefore, I, Dr. Satyendra Singh Dursawat, I.A.S., District Magistrate, Puducherry, do hereby prohibit conducting demonstration, dharna, hunger strike, picketing, *etc.*, by various political parties, organizations and associations of Government employees, labour unions, agriculturists, fishermen, students, *etc.*, and also to carry any type of placards, banners, flags, sticks, *etc.*, within the jurisdiction of Grand Bazaar Police Station and Orleanpet Police Station with immediate effect.

This ban shall not be applicable to Government functions, funeral processions and any other activities proposed by the Government Departments.
