THE APPROPRIATION (No. II) ACT, 2017
(Act No. 8 of 2017)

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the Union territory of Puducherry for the services in respect of the Financial Year 2017-18.

BE it enacted by the Legislative Assembly of Puducherry in the Sixty-eighth Year of the Republic of India as follows :—

Short title.

1. This Act may be called the Appropriation (No. II) Act, 2017.

Issue of ₹ 6945,00,00,000 from and out of the Consolidated Fund of the Union territory of Puducherry for the Financial Year 2017-18.

2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate [inclusive of the sums specified in column (3) of the Schedule to the Appropriation (Vote on Account) Act, 2017] to the sum of six thousand nine hundred and forty-five crore rupees, towards defraying the several charges which will come in the course of payment during the Financial Year from 2017-18 in respect of the services specified in column (2) of the Schedule.

Act No.3 of 2017.

Appropriation.

3. The sums authorized to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
