**NOTIFICATION**

In exercise of the powers conferred by sub-section (2) of section 30 of the Consumer Protection Act, 1986 (68 of 1986), read with the Government of India, Notification S.O. No. 469(E), dated 15th May, 1987, The Lieutenant-Governor, Puducherry is hereby makes the following rules to further amend the Puducherry Consumer Protection Rules, 1987, namely:-

1. *Short title and commencement.*— (i) These rules may be called ‘The Puducherry Consumer Protection (Amendment) Rules, 2016’.

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of rule 3.*— In rule 3 of Puducherry Consumer Protection Rules, 1987 (hereinafter referred to as the said rules), in sub-rule (1), for the words, figures and numbers “Other Members, if sitting on whole-time basis, shall receive a consolidated honorarium of ₹ 15,000 per month and if sitting on part-time basis, a consolidated honorarium of ₹ 1,000 plus ₹ 150 per day of sitting”, the words, figures and numbers “Other Members, if sitting on whole-time basis, shall receive a consolidated honorarium of ₹ 25,000 per month, and if sitting on part-time basis, a consolidated honorarium of ₹ 15,000 plus ₹ 500 per day of sitting” shall be substituted.

3. *Amendment of rule 6.*— In rule 6 of the said rules, in sub-rule (1), for the words, figures and numbers “Other Members, if sitting on whole-time basis, shall receive a consolidated honorarium of ₹ 25,000 per month and if sitting on part-time basis, a consolidated honorarium of ₹ 15,000 plus ₹ 500 per day of sitting” the words, figures and numbers “Other Members, if sitting on whole-time basis, shall receive a consolidated honorarium of ₹ 30,000 per month and if appointed on part-time basis, a consolidated honorarium of ₹ 25,000 per month plus conveyance allowance of ₹ 500 per day of sitting, is admissible if conducted 8 sittings and above per month, or, a honorarium of ₹ 15,000 per month plus ₹ 500 per day for sitting, is admissible if conducted 7 sittings and below per month”, shall be substituted.
