அரசு பொது மருத்துவமனை

ஒப்பந்தப்புள்ளி அறிவிப்பு

காரைக்கால் அரசு பொது மருத்துவமனையில் பயன்படுத்தப்பட்டு பழுதடைந்த நிலையில் இருக்கும் பொருட்களை (பொருட்களின் பட்டியல் இவ்வலுவலக செய்திப் பலகையில் ஒட்டப்பட்டுள்ளது) அவைகள் இருக்கும் இடத்தில் இருக்கும் நிலையிலேயே

4. மேலே குறிப்பிட்டுள்ள கால கெடுவிக்குப்பின் வரும் ஒப்பந்தப்புள்ளிகளும், முன்வைப்புத் தொகை இல்லாத ஒப்பந்தப்புள்ளிகளும் ஏற்றுக்கொள்ளப்படமாட்டாது.

5. ஒப்பந்தத் தொகையையும், அதற்குண்டான அரசு நிர்ணயம் செய்த விற்பனை வரியையும் சேர்த்து மொத்தமாக செலுத்தியபின் பொருட்களை எடுத்துச்செல்ல அனுமதிக்கப்படுவர். ஒப்பந்ததாரர்கள் அப்பொருட்களை தன் சொந்த செலவில் 24 மணி நேரத்திற்குள் அப்புறப்படுத்த வேண்டும். தவறினால் முன்வைப்புத் தொகை திருப்பித்தரப்பட மாட்டாது. அத்தொகை அரசு கணக்கில் சேர்க்கப்படும்.
