A.05/800(01)(01) Puducherry region-(50) Other Charges-Non-Plan”

to the below mentioned head of account:

“0801-Power-05-Transmission and Distribution-101-Sale of Power”

3. The drawal of subsidy every year should be made only with the concurrence of the Finance Department to ensure the effective Budget/Expenditure Management.

4. All other items, terms and conditions remain unaltered.
