GENERAL NOTICE

Whereas, I, Dr. V.J. Chandran, I.P.S., Senior Superintendent of Police (Law and Order), Puducherry, on being satisfied that there is likelihood of breach of peace in Puducherry region, especially within the limits of Police Stations comprising East Sub-division, owing to the proposed agitations/demonstrations by various political parties/organisations/associations and other law and order arrangements, which may cause dislocation of traffic, danger to the community, damages/loss to private and public properties and disturbance to public order.

Now, therefore, in view of ensuing Winter Session of Puducherry Legislative Assembly, I, Dr. V.J. Chandran, I.P.S., Senior Superintendent of Police (Law and Order), Puducherry, in exercise of the powers conferred on me by virtue of section 30(2) of the Police Act (Act V of 1861) do hereby impose the Regulatory Order in Puducherry region, especially within the limits of Police Stations comprising East Sub-division for a period of 7 days from 22-11-2017 to 28-11-2017 (both days inclusive) as follows:

ORDER

No person or class of persons shall convene or collect as an assembly or form or take out any procession or stage any demonstration/picketing on any road or street or thoroughfare or hold public meeting in Puducherry region, especially within the limits of Police Stations comprising East sub-division for a period of 7 days from 22-11-2017 to 28-11-2017 (both days inclusive) except under and in accordance with the terms and conditions of licence issued on this behalf by the undersigned and also do hereby require that every such person or class of persons as aforesaid intending to convene or take out procession or conduct such demonstration/picketing individually or collectively shall apply to the undersigned for licence atleast 48 hours in advance.

This order shall not affect marriages, religious and funeral procession/ ceremonies and Government functions.
