Whereas, the Government is of the opinion that an industrial dispute has arisen between the management of M/s. Sica Brewaries Private Limited, Puducherry and the Union of Sica Brewaries Thozhilalar Munnetra Sangam, Puducherry, over charter of demand and wage revision settlement in respect of the matter mentioned in the Annexure to this order;

And whereas, in the opinion of the Government, it is necessary to refer the said dispute for adjudication;
