No cost.

Consequent on the change of administrative control, separate proposal for revision/fixation of room rent for all the category of accommodation available in the Puducherry Government Guest House at Chennai, was issued in the G. O. Rt. No. 5, dated 18-07-2016 of the Chief Secretariat (Establishment), Puducherry.

- 2. The terms and conditions have not been revised during the recent revision/fixation of room rent. It has been proposed to modify the terms and conditions, as per the terms and conditions issued in G. O. Ms. No. 96, dated 14-09-2016 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.

ANNEXURE

Procedure/Terms and conditions for allotment of rooms

- (1) Non-Government Official Members of any Board or such Members in various Committees constituted by Government of Puducherry will be treated as private Guests when his/her visit is not related to official work.
- (2) The tariff will automatically increase by 10% every year from the date of revision of this year for all categories of guest.

- (3) Room allotment of Central Government officials or other State Government Officials will be made only after accommodating guests of Puducherry Government.
- (4) The officials of other Central/State Government Bodies can be accommodated and rent pertaining to Government Officials of Puducherry can be collected from them only if, they are on an official work related to Government of Puducherry, otherwise such officials will be treated as private guests.
- (5) All private guests have to fill up a Form available at the reception at the time of allotment of rooms, wherein, they have to fill up details of person accompanying them, so that such accompanier will not be able to reserve room in their name for the next 10 days.
- (6) The maximum duration of stay in a spell for all private guests and the officials on personal visits will be 3 days only. If, permitted to stay beyond 3 days, the room tariffs will double for every extra day of occupation.
- (7) The number of times in a month for allotment to private guests is restricted to 3 times only.
- (8) Private guests should pay room rent in advance, *i.e.*, prior to allotment of rooms.
- (9) If, a room is being shared by two or more Officers, separate bill will be raised for each one of them dividing the rent proportionately.
- (10) "Officials of Government of Puducherry" refer to those officials paid from the Consolidated Funds of Government of Puducherry. If, there is any dispute regarding the status of the official, decision of the Assistant Director will be finalised based on production of original Identity Card.
- (11) Government official on official duty should bring their Government Identity Card (Original) with Photo Copy, along with the letter from their respective office for allotment of rooms failing which room allotment will not be treated as "on duty".
- (12) Private Guest from Government of Puducherry should submit photo copy of their Identity Card proof along with a recommendation letter from Hon'ble Ministers/Their Private Secretaries, MLA's, Secretaries or Head of Department failing which room will not be allotted.
- (13) No occupants will be provided extra entitlements of any kind other than the facilities provided in the rooms.

- (14) Any damage of fitting/fixtures or breakage of articles in the rooms during the stay of Guests will be charged as per value assessed by the office.
- (15) Check-in will be allowed for half-a-day as minimum instead of one day. Rent will be collected for 12 hours period.
