ORDER

In exercise of the powers conferred under sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948, read with the notification issued vide G.O. Ms. No. 34/Lab./AIL/G/2013, dated 27-09-2013 and the Order, dated 13th March, 2017, the undersigned hereby revise the rates of Dearness Allowance for the employees employed in "Sweeping and Cleaning" in the Union territory of Puducherry with effect from 01-01-2018 on the basis of rise in the average consumer price index number reaching 299 from 286 (Base year 2001=100) and thereby resulting in an increase of 13 points calculated on the basis of average rates of Dearness Allowance with effect from 01-01-2018.

Accordingly, the Dearness Allowance payable to the employees employed in Sweeping and Cleaning in the Union territory with effect from 01-01-2018 would be ₹ 104.00 per day (cumulative). Further, one day wage with effect from 01-01-2018 will be ₹ 270.00 per day (Basic Pay ₹ 166.00 + Dearness Allowance ₹ 104.00 (cumulative)).

- (i) Review of implementation status in respect of decision taken in the District Level DISHA Committee.

- (iii) Address implementation constrains and give suggestions to improve designs of approved programmes or to make mid-course corrections.
- (iv) Review of flow of funds in fulfillment of State's obligations in relation to various programmes and project.
- (v) Review of constrains impeding the timely implementation of various projects with a view to ensure timeliness in extending the required clearances by State authorities in relations to various developmental projects and resolutions of land issues, if any.
- (vi) Intensively monitor all time bound national initiatives to ensure effective delivery of assets in realization of intended outcomes.
- (vii) Look into complaints/alleged irregularities received in respect of the implementation of the programmes, including complaints of wrong selection of beneficiaries, misappropriation/diversion of funds and recommended follow up action.
- (viii) Giving suitable directions for implementation of DBT and use of Aadhaar seeded accounts for flow of funds to beneficiaries identified under various schemes.
- (ix) Identify issues for follow up with the concerned Central agencies in connection with implementation of Central sector projects.
- (x) Refer any matter pertaining to the programmes monitored under DISHA, if felt necessary, to the Ministry of Rural Development which in turn coordinate with the concerned Ministry for appropriate action and inform the concerned DISHA Committee accordingly.
- (xi) Any other matter with the permission of the Chair.

ORDER

Whereas, an inquiry under rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, has been conducted against Thiru K. Murugaiyan, Driver Gr.-III, Circle-II, Public Works Department, Puducherry, against the complaint of unauthorised absence and absconding from duty, without the sanction of the competent authority.

And whereas, a charge-sheet, dated 17-05-2018 along with statement of articles of charges and imputation of misconduct or misbehaviour had been issued to Thiru K. Murugaiyan, Driver Gr.-III, directing him to furnish his statement of defence.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, had received the charge-sheet sent to his residence and acknowledged the receipt of the same *vide* Acknowledgment, dated 09-06-2018.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, has not submitted his written statement of defence on or before the date specified in Para-2 of the charge-sheet Memo. No.1-18/PW/SE-II/E6/2018/345, dated 17-05-2018 and does not appear in person before the undersigned and otherwise fails or refuses to comply with the provisions of rule 14 of the CCS (CCA) Rules, 1965, or the orders/directions issued in pursuance of the said rule. Thereby, the undersigned held the inquiry against him *ex parte*.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, Circle-II, Public Works Department, Puducherry, had absconded from duty all of a sudden on 23-09-2011 without applying for leave or making any sort of intimation to the leave sanctioning authority/appointing authority. From 23-09-2011 to till date Thiru K. Murugaiyan, Driver Gr.-III, is on unauthorised absence deserting the post. The act of the Government servant is a grave 'negligence of duty'. This grave misconduct of the Government servant, leading to desertion of the post, making it inoperational for a long period and thereby hampering the statutory works to be carried out in the official sector, is unwarranted and is clearly unbecoming of a Government servant.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, right from the date of entry into Government service *i.e.*, 23-02-1987 to till date, is reported to be on unauthorised absence from duty on several occasions. Periodical unauthorised absences followed by attending of duty for a small spell of days are found to be the recurring activities of the Government servant.

Thiru K. Murugaiyan, Driver Gr.-III, has often resorted to absconding from duty by unauthorised absence. Despite, several warnings issued, Thiru K. Murugaiyan, Driver Gr.-III, has never corrected his attitude of negligence to duty at any point of his service. This attitude of violation of the rules and norms set forth to govern the service, by the individual, is highly condemnable and lowers the moral of the person. This attitude of grave negligence to duty pictures the character of Thiru K. Murugaiyan, Driver Gr.-III, to be unfit for Government service.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, has been corresponded on various occasions *vide* Memoranda, dated 15-11-2011, 08-12-2011, 15-02-2012, 23-12-2016, 12-07-2017 and 05-12-2017 with directions to report for duty. Thiru K. Murugaiyan, Driver Gr.-III, neither reported for duty nor replied to any of the above correspondences and thereby exhibited wilful insubordination or disobedience, to the lawful and reasonable orders of his superior. These activities of the Government servant are highly unwarranted. This clearly reveals his 'insubordination' to departmental authorities, grave 'negligence of duty' and complete defiance of 'fundamental rules/conduct rules' and thereby exhibits his character to become unfit for Government service. These are the evident factors for unbecoming of a Government servant.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, after receiving the charge-sheet, has not appeared before the disciplinary authority or represented in any form to sustain the act of his misconduct in the official capacity. This obviously reveals that Thiru K. Murugaiyan, Driver Gr.-III, is well aware of the fact that he has nothing to represent, as the charges levelled are true based on facts and stands proved by virtue of the documents, such as, Memoranda, dated 15-11-2011, 08-12-2011, 15-02-2012, 23-02-2016, 12-07-2017 and 05-12-2017, charge-sheet, dated 17-05-2018 and Acknowledgment, dated 09-06-2018 of the Postal Department.

And whereas, Thiru K. Murugaiyan, Driver Gr.-III, is on unauthorised absence from duty from 23-09-2011 to till date. The case of Thiru K. Murugaiyan, Driver Gr.-III, befits for imposing major penalty of 'removal from service' under the provisions of rule-11 of the CCS (CCA) Rules, 1965. Further, the period of unauthorised absence of Thiru K. Murugaiyan, Driver Gr.-III, had exceeded beyond 6 years and 9 months and thereby, the provisions of F.R. 12 (2) stands invoked.

Now, therefore, the undersigned in exercise of the powers conferred under rule 12 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, hereby declares that the provisions of F.R. 12 (2) stands invoked and thereby, Thiru K. Murugaiyan, Driver Gr.-III, shall be deemed to have resigned from the Government service by virtue of continuous unauthorised absence from duty for a period exceeded beyond 6 years and 9 months, and so the services of Thiru K. Murugaiyan, Driver Gr.-III, are hereby terminated with immediate effect.

The tenders received after the due date and time will summarily be rejected.

2. The intending tenderers may inspect the unserviceable materials during office hours on 23-8-2018 with the permission of the undersigned.

3. The intending tenderers should deposit an earnest money of ₹ 3,000 (Rupees three thousand only) in cash along with sealed tenders. The earnest money deposit of the unsuccessful tenderers will be refunded after finalization of the tender on the same day and earnest money deposit of successful tenderer will be deducted towards the cost of items.
