#### **NOTIFICATION**

The Lieutenant-Governor, Puducherry, is pleased to make the following Amendment to the rules for Grant of Financial Assistant to the Poor Scheduled Caste Pregnant and Lactating Women, 1993, notified *vide* G.O. Ms. No. 24/93-Wel. (SCW), dated the 23rd April, 1993 of the Chief Secretariat (Welfare), Government of Puducherry and to enhance the financial benefit provided in the rules, as follows:—

#### **AMENDMENT**

In the "Rules for Grant of Financial Assistance to the Poor Scheduled Caste Pregnant and Lactating Women, 1993".

- 1. Amendment of rule 1.— In rule 1, of the Rules for Grant of Financial Assistance to the Poor Scheduled Caste Pregnant and Lactating Women, 1993, the short title, extent and commencement shall be substituted, namely:—
- (i) These rules may be called "Rules for Grant of Financial Assistance to the Poor Scheduled Caste Pregnant and Lactating Women under Pradhan Mantri Matritva Vandana Yojana (Amendment) Scheme, 2018".
- (ii) It shall be come into force on the date of issue of this Notification.

#### 2. Amendment of rule 3.—

- (iii) In the said rules, after clause (e) of rule 3, the following shall be included, namely:-
  - "(f) The Non-Scheduled Caste bride who got inter-caste marriage with Scheduled Caste bridegroom is also eligible under the Scheme".

#### 3. Amendment of rule 4.—

(iii) In the said rules, for the existing rule 4, the following shall be substituted, namely:-

#### "4. Quantum of Assistance:-

Subject to the fulfillment of the conditions specified under rule 3, a pregnant/lactating woman shall be entitled for grant of financial assistance of ₹ 18,000 which will be paid in 3 installments for 1st child only through Direct Benefit Transfer mode as indicated below:—

For the 2nd child the Financial Assistance of ₹ 18,000 shall be fully borne by the State Government which will be paid in 2 installments through Direct Benefit Transfer mode as indicated below:—

- (a) The Pre-natal assistance shall be ₹ 3,000 per month for three months prior to the month of delivery.
- (b) The Post-natal assistance shall be ₹ 3,000 per month for three months from the month of delivery"
