Ms. No. 52, dated 28-12-2017 of the Welfare of Differently Abled Persons Department, Government of Tamil Nadu, certain posts are identified suitable for Differently Abled Persons for appointment including Civil Judge/District Judge (Entry Level) in the Tamil Nadu State Judicial Service.
