In order to enhance the quantum of the payment of pension to the retired Ulemas of Waqf Institutions situated in the Union territory of Puducherry from ₹ 1,000 to ₹ 2,000 per month per pensioner, the Lieutenant-Governor, Puducherry, is pleased to make the following amendment to the Ulema Pension Scheme Rules, 2011 issued *vide* Notification in G.O. Ms. No. 28/US (Waqf)/T.10/2011, dated 22nd July, 2011, of the Department of Hindu Religious Institutions and Waqf, Government of Puducherry and published in Extraordinary Gazette of Puducherry in Part II, No. 16, dated 2nd August, 2011, namely:-

AMENDMENT

- 1. *Short title and commencement.* (i) These rules may be called the Ulema Pension Scheme (Amendment) Rules, 2018.
- (ii) They shall be deemed to have come into force with effect from the date of this notification.
- 2. Amendment of rule 6.— In the Ulema Pension Scheme Rules, 2011 (hereinafter referred to as the said rules), in rule 6, for the existing symbol, figures and words "₹ 1,000 (Rupees one thousand only), the following shall be substituted, namely.- "₹ 2,000 (Rupees two thousand only)".
- 3. Amendment of Form-B (Sanction Order).— In the said rules, in Form B, (Sanction Order), for the existing symbol, figures and words, " $\stackrel{?}{\stackrel{?}{\stackrel{}{\stackrel{}}{\stackrel{}}}}$ 1,000 (Rupees one thousand only), the following shall be substituted, namely.- " $\stackrel{?}{\stackrel{?}{\stackrel{}}}$ 2,000 (Rupees two thousand only)".
