NOTIFICATION

The draft of the following rules further to amend the Puducherry Excise Rules, 1970, which the Lieutenant-Governor, Puducherry, has proposed to make in exercise of the powers conferred under section 70 of the Puducherry Excise Act, 1970 (No. 12 of 1970), is hereby published as required under sub-section (1) of the said section for information of all persons likely to be affected thereby and notice is hereby given that the said Draft Rules will be taken into consideration on the expiry of seven days from the date of publication of this notification in the Official Gazette.

Any objections or suggestions which may be received from any person by the Government of Puducherry in respect of the said draft rules within the period specified above will be considered by the Government. The objections or suggestions shall be addressed to the Secretary to Government (Excise), Chief Secretariat, Goubert Avenue, Puducherry.

DRAFT RULES

1. *Short title and commencement.*— (1) These rules may be called the Puducherry Excise (Amendment) Rules, 2017.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of rule 118.*— In Puducherry Excise Rules, 1970, in rule 118, for the existing clause (g), the following shall be substituted, namely:-

"(g) F.L.3. licence (one day licence) . . ₹ 5,000 per day"
