DRAFT AMENDMENT RULES

INDIAN PORTS (PUDUCHERRY) (AMENDMENT) RULES, 2017

- 1. Short title, extent and commencement.— (1) These rules may be called the "Indian Ports (Puducherry) (Amendment) Rules, 2017".
- (2) They shall come into force from the date of issue of the notification.
- 2. Amendment of rule 2.— (1) In the Indian Ports (Puducherry) Rules, 1977, for existing entry (1) under sub-rule (2) of rule 2, the following shall be substituted, namely:—
 - "(1) Lorry and Tractor ₹ 23 for each entry at the Port"
