NOTIFICATION

The following draft proposal for revision of minimum rates of wages payable to the Agricultural labourers in Puducherry and Karaikal regions, which the Lieutenant-Governor, Puducherry, hereby proposes to make in exercise of the powers conferred by clause (b) of sub-section (1) of section 3 of the Minimum Wages Act, 1948 (Central Act XI of 1948), read with sub-section (1) of section 13 of the said Act, is hereby published as required under clause (b) of sub-section (1) of section (5) of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said proposal will be taken into consideration by the Government of Puducherry after the expiry of sixty days from the date of publication of the Draft Proposal in the Official Gazette of Puducherry.

2. Any objections or suggestions, which may be received from any person with respect to the proposal before the expiry of the period specified above, will be considered by the Government of Puducherry.

3. Objections or suggestions should be addressed to the Secretary to Government, Labour Department, Government of Puducherry.

NOTE:

1. Where payment of wages is made in kind or partly in kind and partly in cash, such practice would continue, but, such wages shall not be less than the minimum wages that would have been payable, had they been paid wholly in cash in accordance with the notification.

2. Wherever workers are receiving higher wages, they would continue to receive such higher wages.

3. Every minimum rates of wages specified above is inclusive of all rates, allowing for the basic rate, cost of living allowance and the cash value of concession, if any, but, it does not include the cost of food, if any, supplied to the employees and the cost of food should not be deducted from the Minimum rate of wages paid to the employees.

4. Where there is no difference in the daily hours of work and where the same work or work of similar nature is performed, no distinction in payment of wages should be made in the case of men and women workers, as per the Equal Remuneration Act, 1976.

5. The above revised minimum rates of wages shall also apply to the Agricultural Labourers employed in Colleges and Research Stations under the Agricultural University and Agricultural Farms maintained by the Agriculture, Horticulture and other Government Departments in Puducherry and Karaikal regions.

In exercise of the powers conferred by clause (a) of sub-section (1) of section 3, read with sub-section (1) of section 13 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Lieutenant-Governor of Puducherry is pleased to fix the minimum rates of wages payable to the categories of employees employed in Powerloom Industry in the Union territory of Puducherry, as specified in the Schedule hereunder:

NOTE:

1. In addition to the minimum rates of basic wages fixed herein, the employees shall be paid dearness allowance as indicated below:

(i) The dearness allowance is linked to the Consumer Price Index number of Puducherry city for the month September 2017 *i.e.*, 298 points with base year 2001-100 and every raise of 1 point over and above 298 points an increase of 25 paise (Twenty- five paise only) per day shall be paid as dearness allowance.

(ii) The dearness allowance shall be calculated every year on the 1st April, on the basis of the average of the indices of the preceding twelve months that is from January to December.

(iii) The first calculation shall be effective from the date of publication of this notification in the Official Gazette of Government of Puducherry, based on the average of the Puducherry City Consumer Price Index for the previous year.

2. Where the nature of work is the same, no distinction in the payment of wages shall be made in the case of male and female employees.

3. To arrive at monthly wages, the weekly wages shall be first divided by seven and then multiplied by 30.

4. To arrive at monthly wages, the daily wages shall be multiplied by 30.

5. To arrive at daily wages, the weekly wages shall be divided by 6 and the monthly wages by 26.

6. Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.

The following draft proposal for revision of minimum rates of wages payable to the employees employed in loading and unloading operations in the Union territory of Puducherry, which the Lieutenant-Governor of Puducherry hereby proposes to make in exercise of the powers conferred by clause (b) of sub-section (1) of section 3, read with sub-section (1) of section 13 of the Minimum Wages Act, 1948 (Central Act XI of 1948), is hereby published as required under clause (b) of sub-section (1) of section (5) of the said Act, for the information of all the persons likely to be affected thereby and notice is hereby given that the said draft proposal will be taken into consideration by the Government of Puducherry, after the expiry of sixty days from the date of publication of the said proposal in the Official Gazette of Government of Puducherry.

2. Any objections or suggestions which may be received from any person with respect to the proposal before the expiry of the period specified above, will be considered by the Government of Puducherry.

3. Objections or suggestions should be addressed to the Secretary to Government, Labour Department, Government of Puducherry.

DRAFT PROPOSAL

In exercise of the powers conferred by clause (a) of sub-section (1) of section 3, read with sub-section (1) of section 13 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Lieutenant-Governor, Puducherry, is pleased to revise the minimum rates of wages as specified in the Schedule hereunder payable to the categories of employees employed in the loading and unloading operations in the Union territory of Puducherry.

NOTE:

1. In addition to the minimum rates of basic wages fixed herein, the employees shall be paid dearness allowance as indicated below.

(i) The wages notified above is linked to the Puducherry City Consumer Price Index for the month of September, 2017 *i.e.*, 298 points with base year 2001=100 and every raise of 1 point over and above 298 points an increase of ₹ 0.43 (Paise forty-three only) per point per day shall be paid as dearness allowance.

(ii) The revision of dearness allowance shall be effective from the 1st April of every year on the basis of the average of the indices for the proceeding twelve months that is from January to December.

(iii) The first calculation shall thus be effective from the date of issue of this notification in the Official Gazette of Government of Puducherry, based on the average of the Puducherry City Consumer Price Index for the previous year.

2. Where the nature of work is the same, no distinction in payment of wages shall be made between men and women employees.

3. Wherever the existing wages are higher than the minimum rates of wages fixed herein the same higher wages shall be continued to be paid.
