GOVERNMENT OF PUDUCHERRY CHIEF SECRETARIAT (HEALTH)

(G.O. Ms. No. 24, Puducherry, dated 3rd July 2018)

NOTIFICATION

The Government of Puducherry has reconstituted the Fee Committee under the Chairmanship of Hon'ble Justice N. Authinathan, Judge (Retired) vide G.O. Ms. No. 13, dated 10-4-2018 of the Chief Secretariat (Education), Government of Puducherry to fix/determine the fee structure in unaided Private Professional Educational Institutions of this Union territory of Puducherry.

2. Based on the Proceedings of the earlier Fee Committee orders were issued fixing fee structure tentatively for the MBBS/BDS Courses under Management/NRI quota seats for the Academic Year 2017-18 for the three Self-financing Medical and two Dental Colleges vide Order No. C. 983/H5/Health/2017-18/238, dated 19-7-2017 of Health Secretariat, Puducherry.

3. The Fee Committee under the Chairmanship of Hon'ble Justice N. Authinathan, Judge (Retired), High Court, Madras in its meeting held on 19-6-2018, has fixed the final fee structure for Under Graduate Medical and Dental Courses under Management/NRI quota for the years 2017-18, 2018-19 and 2019-20 as below:

4. Accordingly, the Hon'ble Lieutenant-Governor of Puducherry is pleased to approve the above fee structure for admission of students in Under Graduate Medical and Dental Courses I under Management/NRI quota for the years 2017-2018, 2018-2019 and 2019-2020, subject to the following conditions;

(a) The fee structure prescribed above shall be applicable for the three Academic Years 2017-2018, 2018-2019 and 2019-2020 respectively.

(b) This fee is an all-inclusive of annual fee including various fees like Admission fee, Tuition fee, Special fee, Laboratory/Computer/Maintenance and Amenities fee, Extracurricular activities fee and the other recurring expenditure.

(c) The above fee does not include hostel, transport and the mess charges.

(d) The Committee directs that the students who had already been admitted to MBBS Course at an annual fees of ₹ 12 lakh plus ₹ 50,000 for the year 2017-18 are concerned, the difference between the said amount and the revised amount of ₹ 15.50 lakh plus ₹ 50,000 i.e., ₹ 3.5 lakh, would be payable by those students at the rate of ₹ 50,000 per semester commencing from 3rd semester.

(e) The students who had already been admitted to BDS Course at an annual fees of ₹ 3 lakh plus ₹ 50,000 for Management quota and ₹ 6 lakh plus ₹ 50,000- under NRI quota for the year 2017-18 are concerned, the difference between the said amount and the revised amount of ₹ 6 lakh for management quota and ₹ 9 lakh for NRI quota plus ₹ 50,000 respectively *i.e.*, ₹ 3 lakh, would be payable by those students at the rate of ₹ 50,000 per semester commencing from 3rd semester.

(f) The Educational Institutions are not entitled to collect any kind of fees under any guise except the fees fixed by the Committee. No cash should be received from the students by the Educational Institutions and Demand Draft, Cheque, Bank Pay Order, Digital Transactions like RTGS, NEFT, *etc.*, alone are permissible for payment of fees. The management for all the payments received by them should issue proper and necessary receipts. If, any other amounts are charged under any other head or guise, *e.g.*, donations, the same would amount to charging of capitation fee.

(g) It is made very clear that the Educational Institutions should receive the fee for the concerned academic year only and advance payment for the future academic years are strictly prohibited. If, the academic period's duration is just six months, half of the fee fixed for the academic year alone should be received. If, they had already collected any fees in violation of the above condition, the excess amount so collected should be refunded to the students immediately.

(h) Any deviations of this order will entail serious penal consequences like withdrawal of approval accorded by the Medical Council of India/Dental Council of India, cancellation of the Essentiality Certificate issued by the Government of Puducherry and disaffiliation by the concerned University as well as imposition of hefty fine as penalty.

(i) The management is directed to cover all the students under Students Group Insurance Scheme.

The Government of Puducherry has reconstituted the Fee Committee under the Chairmanship of Hon'ble Justice N. Authinathan, Judge (Retired), *vide* G.O. Ms. No. 13, dated 10-4-2018 of the Chief Secretariat (Education), Government of Puducherry to fix/determine the fee structure in unaided Private Professional Educational Institutions of this Union territory of Puducherry.

2. The fee fixed by the earlier Fee Committee and communicated *vide* Order No. C. 983/H5/Health/2015-16, dated 19-5-2017 of the Health Secretariat, Puducherry, in respect of Sri Venkateshwaraa Medical College Hospital and Research Centre and Mahe Institute of Dental Sciences and Hospital, Mahe is valid up to the year 2017-18 only.

3. The Fee Committee under the Chairmanship of Hon'ble Justice N. Authinathan, Judge (Retired), High Court, Madras in its meeting held on 19-6-2018 has re-fixed the fee structure for Under Graduate Medical and Dental Courses'under Government quota for the above Institutions for the years 2018-19,2019-20 and 2020-21 as below:
