NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, read with the Notification No. 24/78/68-DH(S), dated the 24th September, 1968 of the Government of India, Ministry of Home Affairs, New Delhi, the Lieutenant-Governor, Puducherry, hereby makes the following rules to amend the Government of Puducherry, Law Department (Director in the Directorate of Prosecution) Recruitment Rules, 2003, namely:—

1. Short title and commencement.— (i) These rules may be called the Government of Puducherry, Law Department (Director in the Directorate of Prosecution) Recruitment (Amendment) Rules, 2018.

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. For rule 3 of the Government of Puducherry, Law Department (Director in the Directorate of Prosecution) Recruitment Rules, 2003, the following rule shall be substituted, namely:—

"3. Number of post, its classification and Level in the Pay Matrix.— The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the said Schedule".

3. In the Schedule to the Government of Puducherry, Law Department (Director in the Directorate of Prosecution) Recruitment Rules, 2003;

(a) In column (4), for the column heading and the entries relating thereto, the following column heading and entries shall be substituted, namely:—

"4. Level in the Pay Matrix: Level 11"

(b) In column (12), under the heading "Deputation";

(i) against the Serial No.1 (a) (ii), for the words and figures "the Scale of Pay of ₹ 8,000-13,500", the words and figures "Level -10 in the Pay Matrix" shall be substituted;

(ii) against the Serial No.1(a) (iii), for the words and figures "the Scale of Pay of ₹ 7,450-11,500", the words and figure "Level-7 in the Pay Matrix" and for the word "or" at the end, the word "and" shall be substituted;

(iii) Serial No. I (a) (iv) shall be deleted.
