NOTIFICATION

In exercise of the powers conferred by section 70 of the Puducherry Excise Act, 1970 (No. 12 of 1970), the Lieutenant-Governor, Puducherry, hereby makes the following rules further to amend the Puducherry Excise Rules, 1970, the Draft of the same having been previously published in the Extraordinary Gazette No. 3, Part-II, dated 19th January, 2018, as required by sub-section (1) of section 70 of the said Act, inviting objections and suggestions from all persons likely to be affected thereby, within seven days from the date of publication of the said notification in the Official Gazette;

And whereas, no objections or suggestions have been received within the abovesaid stipulated time and therefore, the Government have decided to confirm the said rules issued in respect of the proposal for amendment of the Puducherry Excise Rules, 1970;

Now, therefore, in exercise of the powers conferred by section 70 of the Puducherry Excise Act, 1970 (No. 12 of 1970), the Lieutenant-Governor, Puducherry, hereby makes the following rules, further to amend the Puducherry Excise Rules, 1970, namely:-

1. *Short title and commencement.*— (i) These rules may be called the Puducherry Excise (Amendment) Rules, 2018.

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of rule 118.*— In the Puducherry Excise Rules, 1970, in rule 118, for the existing clause (g), the following shall be substituted, namely:—

“(g) F.L.3 licence (one day licence) .. ₹ 5,000 per day”
