#### NOTIFICATION

The Draft of the following rules further to amend the Puducherry Contract Labour (Regulation and Abolition) Rules, 1973, which the Lieutenant-Governor, Puducherry, has proposed to make in exercise of the powers conferred under section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970), is hereby published as required under sub-section (1) of section 35 of the said Act for

information of all persons likely to be affected thereby and notice is hereby given that the said Draft Rules will be taken into consideration on the expiry of forty-five days from the date of publication of this notification in the Official Gazette.

2. Any objections or suggestions which may be received from any person by the Government of Puducherry in respect of the said Draft Rules within the period specified above will be considered by the Government.

3. Objections or suggestions shall be addressed to the Secretary to Government, Labour Department, Puducherry.

#### **DRAFT RULES**

1. *Short title and commencement.*— (1) These rules may be called the Puducherry Contract Labour (Regulation and Abolition) Amendment Rules, 2018.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of rule 24.*— In the said rules, for the existing word and figures “₹ 90” the word and figures “₹ 500” shall be substituted.

3. *Amendment of rule 26.*— In the said rules, for the existing sub-rules (1) and (2) of rule 26, the following shall be substituted, namely:-

(1) The fees to be paid for the grant of certificate of registration under section 7 shall be as specified below, namely:-

If, the number of workmen proposed to be employed on contract on any day.

(a) Up to 50	... 2,500
(b) Exceeds 50 but, does not exceed 100	... 5,000
(c) Exceeds 100 but, does not exceed 200	... 10,000
(d) Exceeds 200	... 20,000

(2) The fees to be paid for the grant of a Licence under section 12 shall be specified below, namely:-

If, the number of workmen employed by the contractor on any day-

(a) Up to 50	... 2,500
(b) Exceeds 50 but, does not exceed 100	... 5,000
(c) Exceeds 100 but, does not exceed 200	... 10,000
(d) Exceeds 200	... 20,000

4. *Amendment of rule 30.*— In the said rules, for the existing word and figure “₹ 5” the word and figures “₹ 500” shall be substituted.
