NOTIFICATION

In exercise of the powers conferred by section 70 of the Puducherry Excise Act, 1970 (No. 12 of 1970), the Lieutenant-Governor, Puducherry, hereby makes the following rules further to amend the Puducherry Excise Rules, 1970, the Draft of the same having been previously published in the Extraordinary Gazette No. 19, Part-II, dated 19th April, 2018, as required under sub-section (1) of section 70 of the said Act, inviting objections and suggestions from all the persons likely to be affected thereby, within seven days from the date of publication of the said notification in the Official Gazette;

And whereas, no objections or suggestions have been received within the abovesaid stipulated time and therefore, the Government have decided to confirm the said rules issued in respect of the proposal for amendment to the Puducherry Excise Rules, 1970;

Now, therefore, in exercise of the powers conferred by section 70 of the Puducherry Excise Act, 1970 (No. 12 of 1970), the Lieutenant-Governor, Puducherry, hereby makes the following rules, further to amend the Puducherry Excise Rules, 1970, namely:-

1. *Short title and commencement.*— (1) These rules may be called the Puducherry Excise (Third Amendment) Rules, 2018.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Amendment of rule 5A.— In the Puducherry Excise Rules, 1970, (hereinafter referred to as the said rules), in rule 5A, the following proviso shall be inserted, namely:-

"Provided that the import fee on Rum intended for sale by Canteen Stores Department (CSD) Canteen(s) functioning in the Union territory of Puducherry shall be collected at the rate of 50% of the import fee levied under this rule, subject to the condition that the vend of liquor shall be restricted for sale only to serving personnel/ex-servicemen in accordance with the scales of IMFL to be issued by CSD canteens by the Board of Central Canteen Services, New Delhi, from time to time."

3. Amendment of rule 118.— In the said rules, in rule 118, after sub-rule (b), the following shall be inserted, namely:-

"(bb) FL.1 Licence to Canteen . . 1% of the sum of the fees Stores Department (CSD) payable under sub-rules (a) Canteen. and (b) above."
