proceedings were failed and therefore, this reference has been made to this Court to decide whether the industrial dispute raised by the petitioner Union against the respondent management is justified or not.

- 8. Even though, the Counsels for the respondent has filed vakalt, despite several opportunities, no counter was filed on behalf of the respondent and hence, the respondent was set $ex\ parte$ on 07-03-2018. By the non-appearance of the respondent and non-filing of counter, adverse inference could also be drawn against the respondent. On a careful perusal of the evidence of the PW.1 and Ex.P1 to Ex.P3 it could be held that the petitioner union has proved their case and as such, it is to be held that the industrial dispute raised by the petitioner union against the respondent management over non-payment of $\ref{totaleq}$ 10,000 as $ex\ gratia$ for the year 2014-2015 is justified and the petitioners are entitled for the Order as claimed by them and as such, the petition is liable to be allowed.
- 9. In the result, the petition is allowed and the industrial dispute raised by the petitioner union against the respondent management, over non-payment of $\overline{10,000}$ as *ex gratia* for the year 2014-2015 is justified and Award is passed directing the respondent management to Pay $\overline{10,000}$ as *ex gratia* to their employees for the year 2014-2015. No cost.

- (x) A Representative from NDDB/. Member-NCDC, to be nominated by Convener. Government of India.

- 3. Functions of the State Project Screening and Review Committee (SPSRC) shall be as follows:
 - (i) SPSRC shall screen the proposals presented before it and recommend to NDDB/NCDC for sanction, as per extant norms.
 - (ii) SPSRC shall facilitate the statutory clearance from State Government, if any.
 - (iii) SPSRC shall ensure that there is no duplication of activities, efforts and resources.
 - (iv) SPSRC will review and monitor the progress of the DIDF supported projects at the State Level and monitor as well as review repayment of loans, *etc.*, taken by eligible end borrowers in a timely manner.
- 4. The State Project Screening and Review Committee shall meet at least once in a quarter and as and when required. The Animal Husbandry and Animal Welfare Departments, Government of Puducherry, will act as Nodal Department and will receive the project proposals from eligible end users and place before the SPSRC for decision.

ORDER

Whereas, Thiru P. Srivenkateshwaran was appointed as Drawing Teacher (now re-designated as Fine Arts Teacher) on temporary and regular basis with effect from 27-6-2007. He went abroad (France) after getting No Objection Certificate from the Department by applying Extension of Leave from 1-9-2011 to 31-12-2011. Before proceeding to France, he has furnished an Affidavit, dated 23-4-2011 stating that in the event of non-joining of the duty on 1-1-2012, the affidavit may be treated as letter of resignation with effect from 1-1-2012. Later, he submitted a letter, dated 18-1-2012 for extension of EOL period till 17-1-2012. Thereafter, he remained unauthorized absent from duty. Subsequently, the individual, vide letter dated 4-7-2012, requested to allow him to retire from service voluntarily with effect from 4-7-2012.

And whereas, as per rule 48-A(1) of the Central Civil Services (Pension) Rules, 1972, which specifies completion of twenty years of qualifying service for voluntary retirement. Whereas, he had completed less than 5 years of qualifying service as on 4-7-2012. Thus, he is not eligible for voluntary retirement from service and hence, his request for voluntary retirement should have been rejected immediately besides he should have been asked to tender resignation.

And whereas, now, after a lapse of four years and five months, Thiru P. Srivenkateshwaran requested the Department *vide* letter, dated 19-12-2016 for withdrawal of his earlier request for voluntary retirement from service submitted on 4-7-2012 and requested to permit him to rejoin in service.

And whereas, the intention of Thiru P. Srivenkateshwaran to quit the Government Service is very clear from his letter, dated 4-7-2012 and his subsequent letter, dated 19-12-2016, there is no ground to consider his request for reinstatement. The normal rule is that as long as there is no communication from the Department, the request of the Government Servant is deemed to have been accepted. On the same analogy, the intimation given by the individual on 4-7-2012 that he was leaving

the service on his own from that date shall be deemed to have been accepted as he was not waiting for the response from the Government nor he did seek any relieving order.

And whereas, Thiru P. Srivenkateshwaran has also furnished an Affidavit, dated 23-4-2011 while going to abroad (France), stating that if, he fails to join duty on 1-1-2012, the same may be treated as resignation. The individual being a temporary Government Servant, is covered under rule 5 of the Central Civil Services (Temporary Services) Rules, 1965, which stipulates the termination of Government Service at any time by one month notice in writing on either by the Government Servant to the Appointing Authority or by the Appointing Authority to the Government Servant. In the instant case that the individual himself vide an Affidavit, dated 23-4-2011 has expressed his intention to quit from Government Service by resignation in case of non-reporting to duty on 1-1-2012. Hence, the letter, dated 4-7-2012 deemed to have been treated as letter of resignation.

Now, Therefore, the Hon'ble Lieutenant-Governor, by invoking rule 5 of the Central Civil Services (Temporary Service) Rules, 1965, is pleased to order that Thiru P. Srivenkateshwaran, who was working as Fine Arts Teacher in Government Higher Secondary School, Thenoor, Thirunallar, Karaikal, is deemed to have resigned from the Government service with effect from 4-7-2012.
