NOTIFICATION

In exercise of the powers conferred by section 39 of the Puducherry Agricultural Produce Markets Act, 1973 (No. 3 of 1974), the Lieutenant-Governor, Puducherry, is pleased to make the following rules further to amend the Puducherry Agricultural Produce Markets Rules, 1975 issued *vide* Notification in G.O. Ms. No. 12, dated 1st February, 1975 of the Development Department, Government of Puducherry and published in the Extraordinary issue of the Gazette No. 31, March, 1975, namely:—

AMENDMENT

- 1. Short title and commencement.— (1) These rules may be called as the Puducherry Agricultural Produce Markets (Amendment) Rules, 2018.
- (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Amendment to rule 33.— In the Puducherry Agricultural Produce Markets Rules, 1975, in rule 33, for the existing sub-rule (6), the following shall be substituted, namely:—
 - "(6) Consignments of notified agricultural produce leaving the notified market area shall be accompanied by a permit issued by the Secretary and the Market Superintendents of the regulated market yards of the Pondicherry Market Committee, Puducherry, on application. The permit applied for shall not be issued unless the fees or any other amount due to the Market Committee, if any, has been paid".
- 3. This issues with the approval of the Finance Department *vide* their I.D. No. 1752/FC/FD/F5/A3/2018, dated 28-08-2018.
