Ms. No. 13/79-HEW(HW), dated 31st January, 1979 of the Health, Electricity and Works Department, Puducherry and published in the Gazette No. 8, dated 20-2-1979 (hereinafter referred to as the said rules), namely:—

#### AMENDMENT

- 1. In the said rules, in rule 2 for the word and figures "₹ 1,00,000" thereof, the word and figures "₹ 2,50,000" shall be substituted.
- 2. for rule 3, the following shall be substituted namely:-

"3. The amount of  $\gtrless$  2,50,000 referred to in rule 2 shall be put in the fixed deposit, jointly in the name of the couple (first name being of the woman), for a lock-in period of three years without facility for its premature encashment in a Government/ Nationalized Bank."

3. for rule 6, the following shall be substituted namely:—

"6. The amount referred to in rule 2 shall be paid in the form as stipulated in rule 3, on production of marriage certificate issued by the competent authority along with the application."

2. These orders shall come into force with effect from 14-9-2017, as per the Government of India, Ministry of Social Justice and Empowerment's, Letter No. 11014, dated 14-9-2017.
