NOTIFICATION

- 1. The Government of India has approved a new Scheme namely, "Mahila Shakthi Kendra (MSK)" to provide one stop convergent support services for empowering rural women with opportunities for skill development, employment, digital literacy, health and nutrition.
- 2. The Mahila Shakthi Kendra (MSK) Scheme is envisaged to work at various levels, while State Level structures will provide technical support to the Government on issues relates to women. The District Level

and Block Level Centres will provide support to MSK and also give a foothold to women empowerment schemes including Beti Bachao Beti Padhao (BBBP).

- 4. The Department of Women and Child Development will collate, examine and endorse the Action Plans (SRCW and DLCW and MSK-Block Level) and the Activity Report (MSK) for onward transmission to the Ministry of Women and Child Development.
- 5. The Department of Women and Child Development will furnish to Ministry of Women and Child Development the Utilization Certificate/Statement of Expenditure (six monthly basis) duly signed by designated official.
