NOTIFICATION

G.S.R.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the President hereby makes the following rules to amend the Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, Senior Dietician Recruitment Rules, 1995, namely—

1. *Short title and commencement.*— (i) These rules may be called the Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, "Senior Dietician" Recruitment (Amendment) Rules, 2018.

(ii) They shall come into force on and from the date of their publication in the Official Gazette.

2. For rule 2 of the Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, Senior Dietician Recruitment Rules, 1995, the following rule shall be substituted, namely:-

"2. *Number, classification and Level in Pay Matrix.*— The number of post(s), its (their) classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules".

3. In the Schedule to the Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, Senior Dietician Recruitment Rules, 1995,—

(a) In column (4), for the column heading and the entries relating thereto, the following column heading and entries shall be substituted, namely:—

"Level in Pay Matrix"

NOTIFICATION

G.S.R.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the President hereby makes the following rules regulating the method of recruitment to the post of Clinical Pharmacist in Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, namely:—

1. *Short title and commencement.*—(1) These rules may be called the Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, "Clinical Pharmacist" Group 'A' post, Recruitment Rules, 2018.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Application.—These rules shall apply to the posts as specified in column (1) of the Schedule annexed to these rules.

3. Number of post, its classification and Level in the Pay Matrix.—The number of the said post, its classification and Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

4. Method of recruitment, age-limit, qualifications, etc.—The method of recruitment to the said post, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

Provided that the upper age-limit prescribed for direct recruits may be relaxed in the case of Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders of the Central Government issued from time to time.

5. Disqualifications.-No person,-

(a) who, has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. *Power to relax.*—Where, the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
