#### ORDER

In pursuance to Hon'ble National Green Tribunal Order, dated 16-01-2019 passed in Original Application No. 606/2018 in compliance of Solid Waste Management Rules, 2016, sanction is hereby accorded to the constitution of District Level Special Task Force comprising the following officers for creating awareness about the Solid Waste Management by involving educational, religious and social organisations, etc., including Local Eco-clubs in both Puducherry and Karaikal Districts.

- (1) District Magistrate or his representative not below the rank of Sub-District Magistrate. . . Chairman
- (2) Senior Superintendent of Police or his representative not below the rank of Superintendent of Police. . . Member
- (3) One Official from Puducherry Pollution Control Board . . . Member
- (4) One Member to be nominated by Chairman of Puducherry Legal Services Authority. . . Member
- (5) Representative of Director, School Education Department, Puducherry. . . Member
- (6) Deputy Director (LA), Local Administration Department, Karaikal. . . Member-Secretary.
