NOTIFICATION

Whereas, the Government is of the opinion that an industrial dispute has arisen between the management of M/s. Lanson Motors Private Limited, Kirumampakkam, Puducherry and the union workmen represented by United Labour Federation, Thambu Chetty Street, Chennai, over non-employment of 20% bonus for the year 2016-2017 to the union workmen listed in Annexure-I, in respect of the matter mentioned in the Annexure to this order;

And whereas, in the opinion of the Government, it is necessary to refer the said dispute for adjudication;

Now, therefore, by virtue of the authority delegated vide G.O. Ms. No. 20/90/Lab./L, dated 23-5-1991 of the Labour Department, Puducherry, to exercise the powers conferred by clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), it is hereby directed by the Secretary to Government (Labour) that the said dispute be referred to the Industrial Tribunal, Puducherry, for adjudication. The Industrial Tribunal Puducherry, shall submit the Award within 3 months from the date of issue of reference as stipulated under sub-section (2-A) of section 10 of the Industrial Disputes Act, 1947 and in accordance with rule 10-B of the Industrial Disputes (Central) Rules, 1957. The party raising the dispute shall file a statement of claim complete with relevant documents, list of reliance and witnesses to the Puducherry, within 15 days of the receipt of the order of reference and also forward a copy of such statement to each one of the opposite parties involved in the dispute.

The proposed terms of reference is to:

(i) Review

(a) The administrative, financial and logistics for Malaria Elimination at various levels.

(b) To provide technical guidelines and regular monitoring of progress towards elimination and prevention of re-introduction in areas which have achieved elimination with following objectives:

(i) Eliminate malaria from the Union territory of Puducherry by 2022;

(ii) Interrupt indigenous transmission of malaria in all sub-centre areas by 2020; and

(iii) Prevent re-establishment of local transmission of malaria in areas where it has been eliminated and maintain malaria-free status by 2022 and beyond.

(ii) Key interventions in Malaria Elimination

The State will be undertaking Malaria Elimination in Puducherry under Puducherry Malaria Elimination Campaign, through (a) Surveillance (b) Case detection and management (c) Private Sector reporting of malaria (d) Integrated Vector Management (e) Inter-sectoral coordination and monitoring (f) Legislation (g) Awareness activities and capacity building.

(iii) Action points

(a) Interruption of transmission of Malaria: In elimination areas, where transmission is focal and incidence/risk has become extremely low, all efforts will be directed at interrupting local transmission in all active foci of malaria.

(b) Immediate notification of each detected case: Mandatory notification of each case of malaria from the private sector, other organized Government sectors or any other health facility.

(c) To Detect any possible continuation of malaria transmission: Adequate case-based surveillance and complete case management established and fully functional across the entire Union Territory to handle each case of malaria.

(d) To Forecast and prevent any unusual situations related to malaria, ensure epidemic preparedness and respond in a timely and efficient manner to outbreak situations.

(e) A strict total coverage of all active foci by effective vector control measures.

(f) To prevent re-establishment of local transmission of malaria: Implementation of interventions for effective screening, management and prevention of malaria among mobile and migrant populations.

(g) To ascertain elimination of malaria: Establishment of an effective epidemic forecasting and response system.

(iv) Capacity Building

(a) Review the technical guidelines and training material available and if, any modification is required, need to be communicated to the Directorate of NVBDCP, Delhi.

(b) Review inter-sectoral coordination and review the efforts undertaken towards IEC/Social mobilization and public-private partnership.

(c) Review the nature and extent of operational problems affecting the programme, as well as financial and staffing constraints affecting key interventions for malaria elimination.

(d) Any other relevant matter pertaining to malaria elimination campaign.

(v) Frequency of Technical Advisory Committee (TAC) Meetings

The Technical Advisory Committee will hold the first meeting within 30 days from the date of issue of this Notification and the second and subsequent meetings once in three months. The recommendations made in each STAC meeting will be communicated to all the Members with a copy endorsed to Directorate of NVBDCP within 10 days holding the meeting.
