## GOVERNMENT OF PUDUCHERRY LOCAL ADMINISTRATION SECRETARIAT

(G.O. Ms. No. 20/LAS/A5/2019, Puducherry, dated 28th August 2019)

#### ORDER

Whereas, the Government has notified the Puducherry Municipal Subordinate Services (Revised Pay) Rules, 2018 and the Puducherry Commune Panchayats Subordinate Services (Revised Pay) Rules, 2018 *vide* Government Orders under G.O. Ms. Nos. 17, 18 & 19/LAS/Al/2018, dated 01-10-2018 of Local Administration Secretariat, Government of Puducherry and G.O. Ms. Nos. 26, 27 and 28/LAS/Al/2018, dated 02-11-2018 of Local Administration Secretariat, Government of Puducherry;

2. And whereas, the Finance Department, Government of Puducherry, in pursuance of the Government of India's Resolution Recording the implementation of the Recommendations of the Seventh Central Pay Commission on pension structure of pensioners *vide* O.M.No. 38/37/2016-P&PW(A)(ii), dated 04-08-2016 of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pensioners Welfare, New Delhi, has since communicated the copies of the orders of Government of India *vide* Government Order's furnished hereunder.

On the implementation of the decisions on the recommendations of the Seventh Central Pay Commission for revision of pension to Pre-2016 Pensioners and Family Pensioners, *etc.*, and revision of provision regulating Pension/Gratuity/Commutation of Pension/Family Pension, *etc.*, for Government Servants who retire/die in harness on or after 01-01-2016 and for implementation *vide* Government Order's First and Second cited, as specified therein:

- (A) O.M.No. 38/37/2016-P&PW(A)(i), dated 04-08-2016 on the revision of the provisions regulating the Pension/Gratuity/Commutation Pensions/Family Pension, *etc.*, of the Government Servants who retire/die in harness on or after 01-01-2016.
- (B) O.M.No. 38/37/2016-P&PW(A)(ii), dated 04-08-2016 for revision of Pre-2016 M.F. Pensioners/Family Pensioners.

And Whereas, sub-rule (1) of rule 4 of the Puducherry Municipal Subordinate Services (Retirement and Pension) Rules, 1976 and sub-rule (2) of rule 4 of the Puducherry Commune Panchayat Subordinate Services (Retirement and Pension) Rules, 1976, provide for the application of rule 56 of the Fundamental Rules and the Central Civil Services (Pension) Rule, 1972, to the Municipal Servants and Commune Panchayat Servants, respectively and that the orders, decisions, *etc.* issued by the Government from time to time under the said rules shall *mutatis mutandis* be applicable to the said Municipal/Commune Panchayat Servants;

3. Now, therefore, in pursuance of the Orders already communicated in the G.O. Ms. Nos. 17, 18 and 19/LAS/Al/2018, dated 01-10-2018 of Local Administration Secretariat, Government of Puducherry and G.O. Ms. Nos. 26, 27 and 28/LAS/Al/ 2018, dated 02-11-2018 of Local Administration Secretariat, Government of Puducherry, the Lieutenant-Governor, Puducherry, is pleased to convey her approval to apply the recommendations of the Seventh Central Pay Commission on Pension Structure of Pensioners to all the Local Bodies in the Union territory of Puducherry and for revision of Pension to Pre-2016 Pensioners and Family Pensioners, etc., and revision of the Provisions regulating Pension/Gratuity/ Commutation of Pension/Family Pension, etc., to the employees of Municipalities and Commune Panchayats, who retired/die in harness on or after 01-01-2016, as made applicable to the Government Servants/Pensioners of the Union territory of Puducherry, subject to the strict adherence of all the conditions stipulated in the orders of Government of India referred to in the second paragraph above, (Copies enclosed) alongwith all other conditions stipulated in the G.O. Ms. Nos. 17, 18 & 19/LAS/Al/2018, dated 01-10-2018 of Local Administration Secretariat,

Government of Puducherry and G.O. Ms. Nos. 26, 27 & 28/LAS/Al/2018, dated 02-11-2018 of Local Administration Secretariat, Government of Puducherry and the Puducherry Municipal Subordinate Services (Retirement and Pension) Rules, 1976 and the Puducherry Commune Panchayat Subordinate Services (Retirement and Pension) Rules, 1976, by all the Municipalities and Commune Panchayats.

- 4. The revised Pension/Family Pension in terms of the above-mentioned orders of Government of India shall be fixed notionally with effect from 01-01-2016 but, with monetary benefit from 02-10-2018 as decided in the case of payment of revised pay on the basis of recommendations of the Seventh Central Pay Commission to the employees of Local Bodies.
- 5. The entire expenditure on account of the implementation of revised Pension structure/retirement benefits as 7th CPC recommendation to the Pensioners of Local Bodies (Municipalities/Commune Panchayats) shall be borne by the respective Local Bodies from their own source and the Government of Puducherry will not extend any financial assistance in this regard.
