NOTIFICATION

In exercise of powers conferred under section 33 of "The Rights of Persons with Disabilities Act, 2016" (No. 49 of 2016) an Expert Committee to identify posts in the establishments under the administration of the Union territory of Puducherry which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34 as appended to this Notification is constituted.

- 2. The Committee shall analyse the posts operated by various Government Departments/Autonomous Bodies/Government Undertakings of this administration and identify the posts suitable for persons with benchmark disabilities as specified under section 34 of the Act.
- 3. The terms of reference for the Committee are as follows:-
 - (a) The Committee may co-opt any other member.
 - (b) Meetings of the Committee will be held in Puducherry as per the convenience of the Chairman.
 - (c) The in-station non-official Members of the Committee are entitled for Daily Allowance at the rate of ₹ 1,000 per day of sitting. The out-station non-official Members are entitled to draw the Daily Allowance along with reimbursement of travelling expenses/air fare at economic class. Accommodation shall be arranged at Government Guest House, Puducherry.
 - (d) The Committee shall submit its report within one year.
