Whereas, the Station House Officer, Palloor Police Station, has laid information against you in Cr. No. 47/2018 under section 144 Cr.P.C. alleging that the Counter Petitioner is a native of Palloor and a habitual offender. The Counter Petitioner involved in the opponent party local leader murder case in Cr.No. 32/2018 of Palloor Police Station. The Counter Petitioner was arrested and released on bail

with a condition to sign before Station House Officer, Yanam Police Station daily at 10.00 hrs. and 5.00 p.m. at Yanam Police Station until further orders *vide* Cr.M.P.No. 3716/2018, dated 31-08-2018. The Hon'ble Court modified the condition bail *vide* Cr.M.P.No. 3912/2018 the Counter Petitioner sign every Monday at Yanam Police Station until further orders. The Counter Petitioner came to native place and frequently visit East Palloor, Palloor area in the interim days. The Counter Petitioner is life threat person by the opponent party which create the Law and Order problems in Palloor Police Station limit and causing disturbance to the public peace and tranquility. The Counter Petitioner was involved in the following cases:

And whereas, you were summoned to this Court on 18-12-2018, 27-12-2018 and 10-01-2019 at 3.30 p.m. and the petitioner stated that the Counter Petitioner is main accused in sensational political murder case and he is presently on bail and his presence may lead to break down of law and order condition. The Counsel appeared for the Counter Petitioner and submits the counter.

And whereas, based on the information laid before me, I am satisfied that there are sufficient grounds for proceeding against you under section 144 (i), (ii) and (iii) of Cr.P.C.

Now, therefore, based on the reasons stated above, I, Aman Sharma, Subdivisional Magistrate, Mahe, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the control of my jurisdiction for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Mahe.

Whereas, the Station House Officer, Palloor Police Station, has laid information against you in Cr.No. 48/2018 under section 144 Cr.P.C. alleging that the Counter Petitioner is a native of Chokli which is adjacent to Palloor Police Station limit. He is the life convict prisoner of Viyur Central Prison, Trissur in Cr.No. 433/12 under sections 143, 148, 147, 302, 149, 109, 118, 201, 212, 465, 471 r/w 34 r/w 120 B IPC and S.3,4 of Explosive Substances Act of Vadakara Police Station and came to native place under parole. This was one of the most sensational political murder case. Counter Petitioner is an active worker of CPI(M) Party and his activities are concentrated in Palloor, Chalakkara areas and involved in following cases.

The Station House Officer has stated that there is also reliable information that some hardcore criminals from neighbouring place of Kerala State are regularly visiting Palloor area to consume liquors. Moreover, there is reliable information that the Counter Petitioner has nexus with political criminals in Kerala area. The local Police is keeping close surveillance on the above Counter Petitioner, if, the Counter Petitioner is allowed in Palloor limit, it is apprehended that he will conspire, other political criminals to indulge in serious offences like assault murder, explodes country made bombs, criminal intimidation, obstructions, annoyance, *etc.*, and thereby become a perennial source threat to the community and disturb public peace and order.

And Whereas, the Station House Officer, Palloor Police Station, has prayed to invoke provisions under section 144 (i), (ii) and (iii) of Cr.P.C against you, not to enter into the jurisdiction of Subdivisional Magistrate Court to prevent danger to the human life and properties and to prevent disturbance to the public tranquility and order.

And whereas, you were summoned to this Court on 10-01-2019 at 3.30 p.m. and the petitioner stated that the Counter Petitioner could not be served notice as he has returned back to Central Prison, Viyur, after completion of parole period. The petitioner has stated that the Counter Petitioner is a habitual criminal and may be a threat to law and order situation within Palloor Police Station limit if, he come back on Palloor again.

And whereas, based on the information laid before me, I am satisfied that there are sufficient grounds for proceeding against you under sections 144 (i), (ii) and (iii) of Cr.P.C.

Now, therefore, based on the reasons stated above, I, Aman Sharma, Subdivisional Magistrate, Mahe, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the control of my jurisdiction for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Mahe.

Whereas, the Station House Officer, Palloor Police Station has laid information against you in Cr.No. 49/2018 under section 144 Cr.P.C. alleging that the Counter Petitioner is a permanent resident of Chokli Panchayat in Kerala which is bordering Palloor Police Station and your activities are concentrated in East Palloor and Palloor area and involved many crime cases of Palloor Police Station. You are habitually involving in criminal activities with malicious intent to endanger the human life and property in the Palloor Police Station limit. Further, it is stated that the Counter Petitioner is an active worker of CPI (M) and formed a gang of anti-social elements and is bent upon indulging in crime such as hurt, rioting, affray and disturbance to the public tranquility and order, even using country made bombs

with maliciously endangering human life and property, which have created panic in the minds of local inhabitants and operating illegal activities in the areas of East Pallor, Palloor and adjoining area have become a source of panic among and public. The petitioner has stated that the public of the locality are afraid of you and they do not come forward to lodge any complaint due to fear of retaliation. The witness are having fear to give evidence against the Counter Petitioner and they do not volunteer to give evidence in the cases in which you are an accused. As such the cases against you are ending in acquittal for want of evidence. You are involved in the following cases.

Aggrieved person and public of the locality are afraid of him and they do not come forward to lodge any complaint due to fear of retaliation.

And whereas, the Station House Officer, Palloor Police Station, has prayed to invoke provisions under section 144 (i), (ii) and (iii) of Cr.P.C against you, not to enter into the jurisdiction of Subdivisional Magistrate Court to prevent danger to the human life and properties and disturbance to the public tranquility and order.

And whereas, you were summoned to this Court on 10-01-2019 at 3.30 p.m. and enquired on the cases registered against you and your depositions could not prove your innocence as you pleaded before this Court. The petitioner stated that the respondent has close nexus with political elements in Palloor are and involved in criminal intimidation and instigating crimes in the Palloor Police Station limit and if, permitted in Palloor Police Station limit, he may cause law and order problem.

And whereas, based on the information laid before me, I am satisfied that there are sufficient grounds for proceeding against you under section 144 (i), (ii) and (iii) of Cr.P.C.

Now, therefore, based on the reasons stated above, I, Aman Sharma, Subdivisional Magistrate, Mahe, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the control of my jurisdiction for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Mahe.
