No. 12015/58/2017-MCH, dated 14-08-2017, of the Secretary, Department of Health and Family Welfare, Ministry of Health and Family Welfare, Government of India, New Delhi.

2. The Resident Medical Officer, Rajiv Gandhi Government Women and Child Hospital, Puducherry, who is the Liaison Officer will liaise with the Hon'ble Supreme Court/High Court/District Court and Medical Board and shall be responsible for smooth functioning of the Board as well as communication between the Hon'ble Supreme Court/High Court/District Court and Medical Board

3. The Assistant Director, Department of Women and Child Development, Puducherry, will be the Social Protection Officer in the Committee, in case of request for termination on grounds of rape as per the guidance.

4. If, any of the above Board Members is not available at the point of time of discussion on a case, may be suitably substituted by another Member by the Medical Superintendent or Resident Medical Officer.

5. The function of the Board is to examine the minor girls or women when referred by the Hon'ble Supreme Court/High Court/District Court for late term termination and provide opinion regarding termination or continuation of pregnancy and its impact of on her health as well as on foetal condition/foetal health.

6. The Medical Board will meet immediately after receiving any orders from the Hon'ble Supreme Court/High Court/District Court. The Medical Superintendent, on behalf of the Board, shall submit their confidential and sealed comprehensive report on the prescribed format to the Hon'ble Courts for necessary action within stipulated time or as directed by the Hon'ble Court.
