Ms. No. 26/2007-Wel/SW-IV, dated 25-10-2007 of the Chief Secretariat (Welfare), Puducherry, G.O. Ms. No. 11/2010-Wel(SW-IV), dated 09-10-2010 of the Chief Secretariat (Welfare), Puducherry and G.O. Ms. No. 6/2014-WCD/SW-IV, dated 08-10-2014 of the Women and Child Development Secretariat, Puducherry;

And whereas, consequent on the expiry of 4th extension on 07-10-2017, it has become necessary to re-constitute Puducherry Women's Commission in the Union territory of Puducherry;

And, now, therefore, in exercise of the powers conferred by sub-sections (1), (2) and (3) of section 5 of the Puducherry Women's Commission Act, 2001 (Act No. 2 of 2002), the Lieutenant-Governor of Puducherry is pleased to re-constitute Puducherry Women's Commission to improve the Status of Women in the Union territory of Puducherry and to enquire into unfair practices affecting Women and for matters connected therewith or incidental thereto under sub-section (1) of section 15 of the Puducherry Women's Commission Act, 2001 notified in the Gazette of Puducherry, *vide* Notification No. 4, dated 28-01-2002 for a further period of three years from the date of issue of this Notification.
