## GOVERNMENT OF PUDUCHERRY LOCAL ADMINISTRATION SECRETARIAT

(G.O. Ms. No. 46/LAS/2019, Puducherry, dated 26th February 2019)

#### **ORDER**

Whereas, as per the Draft of the model Bye-laws, communicated in the Memorandum No. 1516/LAD/PPS/Consultant/2017, dated 09-03-2017, of the Local Administration Department, Puducherry, for levy of Solid Waste Management (SWM) charges by Municipalities for removal of solid wastes from residential and non-residential premises, residential houses with plinth area up to 500 sq.ft. only are exempted from payment of Solid Waste Management charge.

- 2. However, Members of Legislative Assembly expressed concerns on the financial burden to the tax payers due to the imposition of Solid Waste Management charges.
- 3. Therefore, while replying to the discussion and Voting on Demands for Grants for District Administration which includes Local Administration, the Hon'ble Minister for Local Administration decided and announced on the floor of the Legislative Assembly during the Budget Session, 2018-19 that residential houses with a total plinth area up to 1000 sq.ft. would be exempted from paying Solid Waste Management charges and residential houses with total plinth area exceeding 1000 sq.ft. but, not exceeding 2000 sq.ft. will have to pay Solid Waste Management charge of ₹ 50 per month and that the residential houses with plinth area more than 2000 sq.ft. will have to pay Solid Waste Management charge of ₹ 100 per month.
- 4. The announcement made by the Hon'ble Minister for Local Administration has been finally approved by the Government.
- 5. A Draft of the Model Final Notification of the Bye-laws as approved and confirmed by the Government is also enclosed for guidance. The Bye-laws would come into operation at the expiration of 15 days from the date of publication in the Official Gazette. An extract of the above-mentioned sections is enclosed for ready reference.
