1. Principal Secretary/Secretary . . Chairperson Health and Family Welfare, State Government.
2. Director, Health Services . . Co-Chair
3. State TB Officer . . Member-Secretary
4. Mission Director, Puducherry . . Member State Health Mission.
5. Project Director, Pondicherry . . Member AIDS Control Society.
6. WHO Representative—TB . . Member Consultant.

7. State Task Force Chairperson . . Member
8. State President, Indian Medical . . Member Association.
9. One Representative of reputed . . Member local NGO/CSO on rotation basis.
10. Licensing Authority, Department . . Member of Drugs Control.
11. Any other special invitee . . Member

**The main objectives of the TB Forum are as follows**

(i) To engage with policymakers and implementers to ensure justice, rights and dignity of TB patients for effective service delivery.

(ii) To supplement and complement Government initiatives to enforce TB patient-friendly law, policy and programmes.

(iii) To reduce stigma and discrimination and ensure social security of TB patients, survivors and their families.

(iv) To improve awareness on various Government schemes, provisions, facilities available for TB patients and to improve treatment literacy and adherence among patients.

(v) To engage in evidence base advocacy with the stakeholders to expand services.

**Term of references of the State TB Forum**

(1) To advice on strategies for engaging communities affected by TB and increasing community participation in TB programme through formation of network of people affected by TB.

(2) To periodically review progress of involvement of community and network of people affected by TB.

(3) Highlighting the concerns and needs of TB patients to work with Government and a broad range of individuals and organisations to develop better and more responsive health services.

(4) Advocating for greater and more equitable access to quality, accurate and independent information for patients to focus at reducing health inequalities, and by campaigning for patients to have the right to be involved in decision-making.

(5) Enabling a dialogue between all stakeholders involved in a TB patient's care such as Government (including local self-Government), medical and paramedical associations, industry, the medical insurance companies, private health care providers and diagnostic centres.

(6) Create and manage resources to sustain and accelerate TB prevention, control, care and treatment services through community engagement and network of people affected by TB.

(7) Facilitate nutritional support, linkages with Social Welfare Schemes, rehabilitation of several TB patients.

(8) Grievance Redressal.

(9) Meetings will be convened at every six months.

5. The function of the Board is to act as a bridge between community, TB patient, health system and Civil Society along with advocacy activities to influence policy changes for accessible, affordable, supportive TB-services to entire population with special focus on poor and vulnerable.

6. The Mission Director on behalf of the Forum shall update the progress of the Forum to the Ministry in the prescribed format.
