Whereas, Dr. Sushma Ankulagandla, who was appointed as General Duty Medical Officer in Health Department, Puducherry with effect from the forenoon of 29-12-2015, had applied for EOL for 3 years from

01-06-2018 to 31-05-2021 to pursue the Postgraduate course of M.S. (O&G) in S.V. Medical College, Thirupathi and proceeded to join the course without sanction of leave;

- 2. And whereas, as per the rule-32 (2) (e) of CCS (Leave) Rules, 1972, the minimum period of service required for grant of EOL on study purpose is 3 years, whereas, the Medical Officer had completed service only for a period of 2 years and 5 months as on the date from which EOL was sought for. Hence, the Head of Office, Deputy Director (Health), Yanam, had called for explanation from the Medical Officer for her wilful absence from duty and had instructed that necessary disciplinary action would be initiated for the misconduct under relevant rule in the event of non-submission of explanation vide Memorandum No. 2018/GHY/Estt./A2/2018-19/1096, dated 13-06-2018. However, she had neither submitted any explanation nor joined duty, but, remained on unauthorized absence from duty with effect from 01-06-2018;
- 3. And whereas, the Medical Officer had not passed the "Departmental Test for Officers of Health Department" and hence, her successful completion of probation could not be declared. Being a temporary Government Servant, one month Termination Notice was issued to the Medical Officer on 17-09-2018 for the misconduct of unauthorized absence with the approval of the Hon'ble Lieutenant-Governor, as per the rule-5(1) of CCS (Temporary Service) Rule, 1965 *vide* Notice of Termination of Service issued under rule 5 (1) of the CCS (Temporary Service) Rules, 1965, dated 17-09-2018;
- 4. And whereas, on receipt of the Notice, the Medical Officer has rejoined duty on 28-09-2018 and has submitted a representation *vide* Representations of Dr. Sushma Ankulagandla, General Duty Medical Officer, dated 28-09-2018 along with service Bond in Form-6 as stipulated in CCS (Leave) Rules, 1972, requesting to grant EOL for undergoing the higher studies from 01-06-2018 to till the completion of course under rule-32 (3) (a) of CCS (Leave) Rules, 1972. Then, she proceeded to continue the course from 29-09-2018;
- 5. Now, therefore, keeping in view of the fact that Dr. Sushma Ankulagandla was allowed to rejoin duty within the termination notice period of one month, the Termination Notice, dated 17-09-2018 issued to the Medical Officer is deemed to have been withdrawn.
