**VILLIANUR COMMUNE PANCHAYAT, PUDUCHERRY***No. 20-1/VCP/REV/2018-19.**Puducherry, the 21st January 2019.***NOTIFICATION**

The Local Administration Department, Government of Puducherry, has directed all Commune Panchayats to notify the places for prohibition, regulation and demarcation of areas and specially designated areas for display of banners, hoardings, wall posters and flex boards, *etc.*, within the Territorial Jurisdiction of respective Commune Panchayats *vide* Office Memo. No. 2754/LAD/PPS(3)/2016, dated 29-09-2016. Accordingly, the rule 10 (a) of Puducherry Municipality (Advertisement Tax) Rules 1976 as have been made applicable also to the Commune Panchayats *vide* Notification issued under G.O. Rt. No. 67/92/LAD, dated 27-07-1992 of the Development Department (LA), Puducherry, which lays down as follows:-

**Rule 10 (a)**

“The Council may, by notification prohibit the erection, exhibition, fixation, retention or display of all or any class of advertisements in or around any street, points or important roads, junction, heavy traffic, public parks in any place of public resort, place or part thereof, of workshop, place of worship, historic public buildings including monuments and in purely residential localities”.

In pursuance of the provisions above, this Commune Panchayat has decided to prohibit hoardings, display of banners, flex boards, wall writing, pasting of posters, graffiti and cut outs, *etc.*, in all the areas of Territorial Jurisdiction of Villianur Commune Panchayat except at the following designated places enclosed in the Annexure-I demarcated for such display of banners, hoardings, flex boards, advertisements, *etc.*, with the prior permission of the Commissioner, Villianur Commune Panchayat, Villianur.

The abovesaid notification/demarcation has been published in consonance of the direction of the Chief Electoral Officer, Puducherry *vide* letter No. 108(1)/2018-130, dated 24-01-2019 for the purpose of the prevention of defacement of open spaces and public property.

**NOTIFICATION**

Based on the recommendations of the Single Member Committee, constituted during 2005, upgraded pay scales were sanctioned to the following eleven (11) posts of the Electricity Department, Puducherry *vide* G.O. Ms. No. 1, dated 07-01-2006 of the Industrial Development (Power) Department, Puducherry.

1. Helper
2. Wireman
3. Lineman
4. Line Inspector
5. Bill Collector
6. Sub-Inspector of Bill Collector
7. Inspector of Bill Collector
8. Commercial Assistant
9. Senior Commercial Assistant
10. Tester
11. Draughtsman

2. Since, the Government of India is yet to agree to regularize the above-mentioned upgraded pay scales for the said posts of the Electricity Department, Puducherry, this Administration was unable to process service matters of the said post benefiting the officials, such as framing/amendments of Recruitment Rules, grant of financial upgradation under ACP/MACP Scheme, promotion, direct recruitment, *etc.*, in these posts.

3. Now, the Council of Ministers has resolved to grant financial upgradation under ACP/MACP Scheme to all eligible employees officiating in the posts mentioned at para-1, based on the existing Recruitment Rules in the upgraded pay scales.

4. The Lieutenant-Governor, Puducherry, is pleased to approve for “(i) grant of financial upgradation under ACP/MACP Scheme to all eligible employees officiating in the posts of Electricity Department/ mentioned at Para-1 based on the existing Recruitment Rules and in the upgraded pay scales”, and “(ii) to approach the Government of India to regularize the pay upgradation done by this Administration *vide* G.O. Ms. No. 1, dated 07-01-2006 of the Industrial Development (Power) Department, Puducherry.

5. Finance Department, Puducherry, has concurred with the proposal *vide* I.D.No. 1912/FD/F3/2018/FC, dated 24-01-2019 subject to the following:

(i) The Department shall take all expeditious steps to get the ratification of the Government of India for the upgraded pay scales commended by the Single Member Committee for the cadres in respect of Electricity Department, Puducherry.

(ii) In the event of non-ratification of upgraded pay scales by the Government of India, the excess payment made to the employees on account of grant of ACP/MACP Scheme benefits in the upgraded pay scales shall be recovered. Necessary undertaking to this effect shall be obtained from the employees concerned.

(iii) The financial implications consequent on this proposal shall be incurred within the Budget provision of the Electricity Department. The payment of ACP/MACP Scheme arrears shall be as per the extant orders thereon issued by the Finance Department *vide* I.D. Note No. G.24011/2/2016-17/F1(B), dated 19-06-2017 and Circular No. 25-1/FD(W&M)2012, dated 05-08-2016.
