NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F.5/4/65-GP, dated 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi, and Government of Puducherry, Elections Department's G.O. Ms. No. 02/Elections/2018-19, dated 29-11-2018 in so far as it relates to the post of Deputy Tahsildar on temporary basis, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'B' (Non-Gazetted) post of Deputy Tahsildar created in the Elections Department, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Government of Puducherry, Elections Department, Group 'B' (Non-Gazetted) (Temporary) post of Deputy Tahsildar in Elections Department Recruitment Rules, 2019.
- (2) They shall come into force on and from the date of their publication in the Official Gazette and valid up to the creation of permanent posts of Deputy Tahsildar or conversion of these temporary posts into permanent ones.
- 2. Number of post, its classification and Level in the Pay Matrix.— The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age-limit and other qualifications.— (a) The method of recruitment to the said post, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
 - (b) This Recruitment Rules shall be applicable only as and when these temporary posts are operated.
 - 4. Disqualifications.— No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where, the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he/she may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect the reservations, relaxation in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
