AMENDMENT

1. *Short title and commencement.*— (1) These rules may be called as the Puducherry Motor Vehicles (Amendment) Rules, 2019.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Amendment of rule 252.— In the Puducherry Motor Vehicles Rules, 1989, in rule 252 (1), following amendment shall be made, namely:-

"(i) In the Table for "Service charges for Driving Licence", in the entries against Sl. No.(1), Column No. 3, for the figures "15", the figures "30", shall be substituted .

(ii) In the Table for "Service charges for Driving Licence", in the entries against Sl. No. (2) to (12), Column No. 3, for figures "100" the figures "150", shall be substituted.

3. An account called "Personal Deposit Account" shall be operated by the Transport Commissioner in accordance with the General Financial Rules. The amount collected towards service charges shall be utilized for settlement of payment due to the vendor of Smart Card and the remaining amount if any, will be utilized for developmental activities of the Department.

4. The Transport Department shall ensure deduction of applicable IGST/TDS @ 2% as per DAT's Circular, dated 28-09-2018.
