NOTIFICATION

In supersession of the G.O. Ms. No. 40, dated 03-06-2015 and G.O. Ms. No. 62, dated 29-09-2015 of the Home Department, Government of Puducherry, save as respects things done or omitted to be done before such supersession, the Hon'ble Lieutenant-Governor, Puducherry, is pleased to re-constitute the District Level Under-Trial Review Committees in the Union territory of Puducherry to consider the cases of all under-trial prisoners who are entitled to the benefit of section 436A of the Code of Criminal Procedure, 1973 as per the Guidelines of the Ministry of Home Affairs, Government of India, New Delhi, in accordance with the directions of Hon'ble Supreme Court of India in W.P. (Civil) No. 406 of 2013, dated 31-10-2017, with the following compositions:-

The abovesaid Committees, in the first six months of the year 2019, will meet once in a month to review the cases of under-trial prisoners who are entitled to the benefit of section 436A of the Code of Criminal Procedure 1973 and to comply with the above directions of the Hon'ble Supreme Court of India and submit a report to the Legal Services Authority. The reports will then be complied and forwarded to NALSA (National Legal Services Authority).
