ORDER

Whereas, the Police Department, Puducherry, had notified 390 vacancies for the post of Police Constable during August-2018 and called for application from the eligible candidates of Union territory of Puducherry as per the Recruitment Rules-2010 for the post of Police Constable, issued *vide* Official Gazette No. 22, dated 01-06-2010, wherein, the age-limit is prescribed as “between 18-22 years” for general candidates. On issue of notification, several representations were received seeking for extension of upper age-limit from 22 to 24 years;

2. And whereas, in the meanwhile, Thiru Mugilan and 66 others from Puducherry have filed an O.A. No. 1477 of 2018 before the Hon’ble CAT, Chennai Bench, on which, the CAT has passed an order on 31-10-2018 and has directed the Government respondents to take a decision on the representation of the applicants, dated 23-08-2018 by passing a detailed, reasoned and speaking order within one month from the date of receipt of a certified copy of the Tribunal’s order. Further, the Hon’ble CAT has also disposed the application at

the admission stage and made it clear that nothing has been commented on the merits of the case. Similarly, Thiru D. Senthilnathan and 25 others, Puducherry, have filed an O.A. No. 1656 of 2018 before the Hon’ble CAT, Chennai Bench, seeking for relief of same nature;

3. Now, therefore, after careful consideration of representations, the Lieutenant-Governor, in exercise of the powers conferred by the President under the proviso to Article 309 of the Constitution of India, read with the Notification F.No. 5/4/65-GP., dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi, is pleased to accord approval to relax the upper age-limit by two years as a onetime measure in the proposed recruitment of Police Constable in the Police Department, Puducherry and all other conditions in the notification, dated 20-08-2018, shall remain unaltered. Accordingly, an advertisement shall be issued giving one month’s time to apply for the post, so that all eligible candidates with age-limit (relaxed) of 24 years as on 22-09-2018, may avail the opportunity to apply for the post. Those who have already applied for the post need not apply again. The crucial date for determining the age-limit shall be 22-09-2018.

ORDER

Whereas, an application, dated 20-03-2018 was received from Thiru N. Ajeet Kumar Jain, Pawn Broker, No. 67, Carpenter Street, Nellithope, Puducherry-605 005, requesting the permission of the District Magistrate to sell unredeemed and time barred articles in public auction on 28-06-2019.

2. And whereas, the Deputy Collector (Revenue) North, Puducherry, has been requested to verify the list of unredeemed time barred articles physically and ascertained that they remain unredeemed after the time allowed for redemption and hence, the unredeemed and time barred articles list submitted by the Pawn Broker was forwarded to the Deputy Collector (Revenue) North, Puducherry for causing physical verification of the articles mentioned by the Pawn Broker for auctioning.

3. And whereas, the Deputy Collector (Revenue) North, Puducherry, has furnished the report, stating that the Tahsildar, Taluk Office, Puducherry, had conducted physical verification of the articles that are unredeemed and time barred pledged with Thiru N. Ajeet Kumar Jain, Pawn Broker, No. 67, Carpenter Street, Nellithope, Puducherry and reported that the articles mentioned in the petition remained unredeemed past the time allowed and the articles are kept in the licensed premises itself except catalogue Nos. 19, 21, 30, 33, 56, 63, 99, 106 and 117 of the list, which was redeemed.

4. And whereas, the rule 12 of the Puducherry Pawn Brokers Rules, 1966 prescribes procedure in auction of pledges.

5. Now, therefore, Thiru B. Karthikeyan, Thirupathiripuliyur, the authorised Auctioneer is permitted to conduct the sale of unredeemed time barred articles, pledges as shown in the list enclosed and available with the pawn broker, Thiru N. Ajeet Kumar Jain, Pawn Broker, No. 67, Carpenter Street, Nellithope, Puducherry-605 005, in public auction in the licensed premises of the pawn broker at the above address, as per the list approved and sent to the Pawn Broker and the Auctioneer except catalogue Nos. 19, 21, 30, 33, 56, 63, 99, 106 and 117 of the list, which were redeemed. The Pawn Broker and auctioneer shall observe the above formalities detailed as required under the rules framed under The Puducherry Pawn Brokers Act, 1966, before conducting the sale of time barred and unredeemed pledged articles in the public auction.
