## ORDER

[Under Section 144 of Cr.P.C.] (IR No. 45/18 of Palloor Police Station)

State rep. By the Station House Officer., Palloor Police Station.

Petitioner

Thiru Rajeesh @ Masthan Rajeesh (34), S/o. Rajan, Kuttambally House, Pandakkal. **Counter Petitioner** 

Whereas, the Station House Officer, Palloor Police Station, has laid information against you in IR.No. 45/2018 under section 144 of Cr.P.C. alleging that the Counter Petitioner is habitual criminal and committing criminal activities with *malicious* intent to endanger the human life and property in Palloor Police Station limit. He is a trouble maker and is being watched by Police unobtrusively in the interest of public order and his activities are closed watched. The Counter petitioner is an active worker of RSS/BJP and the public of the locality are afraid of him and they do not come forward to lodge any complaint due to fear of retaliation.

He has involved in the following cases.

- 1. Cr.No. 62/07 under sections 143, 147, 427, 506 (ii) IPC r/w 149 IPC : Acquitted.
- 2. Cr.No. 75/07 under sections 341, 324, 506 (ii) IPC r/w 34 IPC : Acquitted.
- 3. Cr.No. 32/08 under sections 341, 323, 427, 506 IPC r/w 34 IPC : Compounded.
- 4. Cr.No. 30/2010 under sections 294, 506(ii) IPC Convicted.
- 5. Cr.No. 44/10 under section 34 E2 of PP Act : Convicted
- Cr.No.116/15 under sections 34 BIX, 34 E1, 341, 294 (b), 323, 506 (ii) IPC r/w 34 IPC : Acquitted.

The petitioner further stated that the abovesaid counter petitioner is committing violence in the area and its surrounding area and also creating fear in the minds of the general public. There is apprehension of imminent breach of peace and public tranquillity which may cause loss of life and property to the public.

And whereas, the Station House Officer, Palloor Police Station, has prayed to invoke provisions under section 144 (i), (ii) and (iii) of Cr.P.C. against you, not to enter into the jurisdiction of Subdivisional Magistrate Court to prevent danger to the human life and properties and to prevent disturbance to the public tranquillity and order.

And whereas, based on the information laid before me, I am satisfied that there are sufficient grounds for proceeding against you under section 144 (i), (ii) and (iii) of Cr.P.C.

Now, therefore, based on the reasons stated above, I, Aman Sharma, Subdivisional Magistrate, Mahe, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the control of my jurisdiction for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Mahe.
