ORDER

(UNDER SECTION 144 OF Cr. P.C.)

Whereas, the Election Commission of India had declared under sub-section (2) of section 58 of clause (a) under the Representation of the People Act, 1951 that a repoll will be conducted on 12-05-2019 from 7.00 a.m. and to 6.00 p.m. at Polling Station No. 10/10 Kamaraj Nagar Assembly Segment situated at 1st Cross Street, Venkata Nagar, Office of the Junior Engineer (O&M), Electricity Department of Puducherry Parliamentary Constituency as the earlier poll conducted was declared as void;

And whereas, in view of the General Elections to the House of People – 2019, the Election Commission of India has issued various instructions *vide* Standard Operating Procedures for last 48 hours, to restrict the assembly/movement of people by invoking the provisions of section 144 of Code of Criminal Procedure, 1973;

Now, therefore, for smooth conduct of Elections in a free and fair manner, and in strict enforcement of the Model Code of Conduct to prevent distribution of Cash or kind to the voters, I, T. Sudhakar, Subdivisional Magistrate (North), Puducherry, hereby invoke the provisions of section 144 of the Code of Criminal Procedure, 1973 and prohibit the assemblage of five or more persons in public streets or thoroughfares or in public places and prohibit the carrying of weapons, sticks, banners, placards, *etc.*, by any person and also prohibit the shouting of slogans and using of Loud Speakers and acting in any other manner detrimental to public peace and tranquility in the areas coming under the jurisdiction of Superintendent of Police (East) from 6.00 p.m. of 10-05-2019 to 6.00 a.m. of 13-05-2019;

This order dose not apply to purely religious functions, marriages, funerals and inside the Polling Booth premises for voting purpose.
