ORDER

[Under Section 8 (2) [a] of the Puducherry Prevention of Anti-Social Activities Act, 2008 and Under Section 82 of Cr.P.C. Requiring the appearance of absconding person under Puducherry Prevention of Anti-Social Activities Act, 2008].

Whereas, a detention order was issued against Thiru Jana @ Janarthanan, s/o. And whereas, it has been shown to my satisfaction that Thiru Jana @ Janarthanan has absconded or is concealing himself and evading his arrest;

Now, therefore, the said absconding person Thiru Jana @ Janarthanan, s/o. Abimannan, residing at No.7, Sudalai Street, Kalitheerthalkuppam, Puducherry, is hereby ordered to appear before the undersigned at the Office of the District Collector-*cum*-District Magistrate, located at 1st Floor, Vazhudhavoor Road, near Rani Hospital, Pettayanchathiram, Puducherry-605 009, to answer the report of the Superintendent of Police (West), Puducherry, on the 4th day of December, 2019.
